RESOLUTION 25-R__

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, REPEALING RESOLUTION 10-R79; ADOPTING THE UPDATED RETIREE HEALTH INSURANCE COVERAGE POLICY FOR THOSE EMPLOYEES HIRED ON OR AFTER JULY 12, 2010 (A "RULE OF 62"); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie ("City"), by and through the City Council, has adopted a system of employee benefits, which includes the City Health Insurance Plan for eligible employees of the City; and

WHEREAS, Section 112.0801, Florida Statutes requires public employers to offer to retirees and their eligible dependents continued health and hospitalization insurance coverage that is the same as is offered to active employees; and

WHEREAS, via Resolution 10-R49, the City established and adopted a Rule of 75, which outlined the criteria for service and age eligibility to continue their participation in the same health and hospitalization insurance plan as a retiree; and

WHEREAS, the City Council desires to repeal and declare ineffective the previously adopted Resolution 10-R49 and its corresponding Rule of 75; and

WHEREAS, the Retiree Health Insurance Coverage Policy for those hired on or after July 12, 2010, also referred to as the Rule of 62, attached hereto as Exhibit "A" and incorporated herein by specific reference, shall supersede and replace the Rule of 75.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1</u>. <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2</u>. <u>Repeal of Resolution</u>. Resolution 10-R49 and the corresponding Rule of 75 is hereby repealed in its entirety and shall be of no further effect.

<u>Section 3</u>. <u>Adoption</u>. The Retiree Health Insurance Coverage Policy for those hired on or after July 12, 2010 (*i.e.*, the Rule of 62), which is attached to this Resolution as Exhibit "A", is hereby adopted and effective.

<u>Section 4</u>. <u>Conflict</u>. If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 5</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 6</u>. <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
