

**AMENDMENT NO. 2
TO AGREEMENT NO. NS082
BETWEEN
FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION
AND
THE CITY OF PORT ST. LUCIE**

This Amendment to Agreement No. NS082 (Agreement), as previously amended, is made by and between the Department of Environmental Protection (Department), an agency of the State of Florida, and the City of Port St. Lucie (Grantee), on the date last signed below.

WHEREAS, the Department entered into the Agreement with the Grantee for the Control Structure SWW-1 Rehabilitation (Project), effective September 15, 2021; and,

WHEREAS, the Grantee has requested an extension of the Agreement due to delays caused by a faulty electric actuator which requires removal and reinstallation; and,

WHEREAS, other changes to the Agreement are necessary; and,

WHEREAS, the parties have agreed to amend the Agreement as set forth herein.

NOW THEREFORE, the parties agree as follows:

1. Section 3. of the Standard Grant Agreement is hereby revised to change the Date of Expiration to March 31, 2026. The Department and the Grantee shall continue to perform their respective duties during this extension period pursuant to the same terms and conditions provided in the Agreement.
2. The following is hereby added to Attachment 1 in Section 8:
State Funds Documentation. Pursuant to section 216.1366, F.S., if Contractor meets the definition of a non-profit organization under section 215.97(2)(m), F.S., Contractor must provide the Department with documentation that indicates the amount of state funds:
 - i. Allocated to be used during the full term of the contract or agreement for remuneration to any member of the board of directors or an officer of Contractor.
 - ii. Allocated under each payment by the public agency to be used for remuneration of any member of the board of directors or an officer of the Contractor.The documentation must indicate the amounts and recipients of the remuneration. Such information must be posted on the State's contract tracking system and maintained pursuant to section 215.985, F.S., and must be posted on the Contractor's website, if Contractor maintains a website.
3. Attachment 3, Grant Work Plan, is hereby deleted in its entirety and replaced with Attachment 3-1, Revised Grant Work Plan, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 3 shall hereinafter refer to Attachment 3-1, Revised Grant Work Plan.
4. Attachment 5, Special Audit Requirements, is hereby deleted in its entirety and replaced with Attachment 5-1, Revised Special Audit Requirements, as attached to this Amendment and hereby incorporated into the Agreement. All references in the Agreement to Attachment 5, shall hereinafter refer to Attachment 5-1, Revised Special Audit Requirements.

5. All other terms and conditions of the Agreement remain in effect. If and to the extent that any inconsistency may appear between the Agreement and this Amendment, the provisions of this Amendment shall control.

The parties agree to the terms and conditions of this Amendment and have duly authorized their respective representatives to sign it on the dates indicated below.

ATTACHMENT 3-1 REVISED GRANT WORK PLAN

PROJECT TITLE: Control Structure SWW-1 Rehabilitation

PROJECT LOCATION: The Project will be located in the City of Port St. Lucie within St. Lucie County; Lat/Long (27.2865111, -80.2747083)

PROJECT BACKGROUND: Excessive nutrient loading from home fertilizer use is one of the biggest water quality issues facing the St. Lucie estuary, contributing in part to excessive algae growth. Algae blooms block sunlight from reaching plant life at the bottom of the waterway, causing them to die off and decompose in a process that depletes the amount of dissolved oxygen in the water.

The City of Port St. Lucie (Grantee) proposes to modify the SWW-1 control structure to treat runoff from 504.5-acres of tributary drainage basins. The SWW-1 structure controls flow between the Tiffany Basin (control elevation 10.5 NAVD) and the Backwell Basin (control elevation 12.5 NAVD) of the City of Port St. Lucie Eastport SWM System. The project will slow, spread, soak, and filter water before it discharges into Warner Creek and the North Fork of the St. Lucie. Expected nutrient load reduction is estimated at 17.65 lbs/yr of total nitrogen (55.0%), 3.72 lbs/yr of total phosphorus (68.5%), 5,809.56 lbs/yr of biological oxygen demand (72.0%), and 18,193.2 lbs/yr of total suspended solids (47.5%).

PROJECT DESCRIPTION: The Grantee will rehabilitate the existing manually-operated SWW-1 structure and update its operation to include remote telemetry controls, to allow the transfer of stormwater between two basins which are currently served by separate pump stations. The project will include a transfer pump at the same location to pump excess stormwater from the Tiffany Basin up to the Blackwell Basin to provide additional treatment, storm attenuation, reduce nutrient loading to the St Lucie River, and promote ground water recharge.

The DEP Grant Funds associated with this Agreement were awarded based on local contributions pledged towards the total project costs: \$224,520.28 from the City of Port St. Lucie. A summary of the local contributions will be required in the Final Report, and financial supporting documentation of locally pledged contributions shall be provided upon request.

TASKS: All documentation should be submitted electronically unless otherwise indicated.

Task #1: Construction

Deliverables: The Grantee will construct the Control Structure SWW-1 Rehabilitation in accordance with the construction contract documents.

Documentation: The Grantee will submit: 1) a signed acceptance of the completed work to date, as provided in the Grantee's Certification of Payment Request; and 2) a signed Engineer's Certification of Payment Request. Upon request by the Department's Grant Manager, the Grantee will provide additional supporting documentation relating to this task.

Performance Standard: The Department's Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department's Grant Manager, the Grantee may proceed with payment request submittal.

Payment Request Schedule: The Grantee may submit a payment request for cost reimbursement no more frequently than monthly.

Task #2: Final Report

Deliverables: The Grantee will prepare a Final Report summarizing the results of the project, including all tasks in the Grant Work Plan. The Final Report must include at a minimum:

- Project location and background, project description and timeline, grant award amount and anticipated benefits.
- Financial summary of actual costs versus the budget, along with any changes required to the budget. Include any match or locally pledged contributions provided, along with other related project work performed outside of this Agreement to identify the overall project cost.
- Discussion of project schedule versus actual completion, including changes required to the schedule, unexpected site conditions and adjustments, significant unexpected delays and corrections, and/or other significant deviations from the original project plan.
- Summary of activities completed as well as those not completed and why, as well as a brief summary of any additional phases yet to be completed.
- Dated color photographs of work performed (representative of the entire project), appropriate figures (site location, site plan(s), etc.), appropriate tables summarizing data/information relevant to Grant Work Plan tasks, and appropriate attachments relevant to the project.
- Projects associated with and listed in a Water Quality Restoration Plan are expected to be maintained for the life of the project to retain reduction credits under the Plan(s) unless noted otherwise. If possible, identify the expected lifetime of the Best Management Practices (BMPs) and if there is a detailed plan to operate and maintain the system through this period. If possible, describe the amount of time, cost, and work will be required to operate and maintain the system.

Documentation: The Grantee will submit: 1) a copy of the draft Final Report in Word format; and 2) a copy of the Department-approved Final Report in Word or PDF format.

Performance Standard: The Department's Grant Manager will review the documentation to verify that the deliverables have been completed as described above. Upon review and written acceptance by the Department's Grant Manager, the Grantee may proceed with payment request submittal.

Payment Request Schedule: The Grantee may submit a payment request for cost reimbursement or match documentation following the conclusion of the task

PROJECT TIMELINE & BUDGET DETAIL: The tasks must be completed by, and all documentation received by, the corresponding task end date. Cost reimbursable grant funding must not exceed the budget amounts as indicated below.

Note that, per Section 8 of Attachment 1 in the Agreement, authorization for continuation and completion of work and any associated payments may be rescinded, with proper notice, at the discretion of the Department if the Legislature reduces or eliminates appropriations. Extending the contract end date carries the risk that funds for this project may become unavailable in the future. This should be a consideration for the Grantee with this and future requests for extension.

Attachment 5-1

MONITORING

The recipient further agrees to comply and cooperate with any inspections, reviews, investigations, or audits deemed necessary by the Chief Financial Officer (CFO) or Auditor General.

AUDITS

PART I: FEDERALLY FUNDED

1. A recipient that expends \$1,000,000 or more in Federal awards in its fiscal year, must have a single or program-specific audit conducted in accordance with the provisions of 2 CFR Part 200, Subpart F.
