This Amendment #1 by and between the City and the Consultant, as defined below, shall be effective as of the date this Amendment #1 is fully executed.

WHEREAS, the Contract is in effect through the Current Contract Expiration Date as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. **TIME EXTENSION**. The parties hereby agree that the Contract will be extended for an additional period of time as follows:
 - a. Extend Contract term for an additional nine (9) months:
 - Beginning Date of Amendment #1 Term: June 12, 2023.

- End Date of Amendment #1 Term: March 31, 2024.
- b. The parties agree the Contract will expire at midnight on the date defined as the "End Date of Amendment #1 Term" unless the parties agree to extend the Contract for an additional period of time. Such agreement must be written and signed by both parties.
- 2. **ADDITIONAL SERVICES.** The Northport conceptual site design has been significantly further expanded through the process. The location of the covered storage area has been moved off the former deep injection well pad to a location farther south on the site. The degree of site improvements being proposed is also more significant than originally envisioned to include large fleet parking, driveways, and possibly a new site entrance to St James Drive.

The City has requested the final design services for the Northport site be produced in two design deliverable packages. The initial site improvements design package would include overall site improvements such as clearing, grubbing, and site balancing. The City desires to commence this work by the end of FY 22/23. The second design package would consist of all other work within the initial phase facilities including driveways, parking, and the covered storage structure.

Revise the subtasks under Task B: Final Design Engineering Services, to be as follows:

a) Perform a specific purpose engineering survey of the northern 11.5 acres +/- of the Northport site (extending from the northern property boundary south approximately 850 ft). The survey will locate the approximate location of the known existing underground utilities using Ground Penetrating Rader per American Society of Civil Engineering Standard 38-03, Quality Level B. Locations of utilities will be collected via aerial done and/or GPS coordinates. Additional site features will be collected by conventional survey methods.

Preparation of the Site Improvements Design Documents

- b) Prepare 60% design documents package for initial site improvement package including site plan with clearing, grubbing, and overall site balancing. Submit 60% design documents package to the City.
- c) Attend a 60% design review meeting with the City.
- d) Prepare 90% design documents, including technical specifications, incorporating comments from the 60% design review.
- e) Attend a 90% design review meeting with the City.
- f) Submit final design drawings and specifications incorporating comments from the 90% design review. Include an Engineer's Opinion of Probable Cost with the final design submittal.

Consultant shall still be responsible for completing tasks a) – f) under TASK B in the Contract.

Additionally, the Section IV – Time of Performance of the Contract shall be amended to include the additional work described in this Amendment #1.
