A RESOLUTION APPROVING THE PRELIMINARY AND FINAL PLAT WITH CONSTRUCTION PLANS FOR MATTAMY AT SOUTHERN GROVE PLAT 1 REPLAT WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF MATTAMY PALM BEACH, LLC (P20-127); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Port St. Lucie, Florida has been requested by Kinan Husainy, Kimley-Horn and Associates, Inc., acting as agent for Mattamy Palm Beach, LLC to approve the preliminary and final plat with construction plans for Mattamy at Southern Grove Plat 1 Replat, within the City of Port St. Lucie, Florida; and

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

That the City Council hereby approves the preliminary and final plat with construction plans for Mattamy at Southern Grove Plat 1 Replat, within the City of Port St. Lucie, Florida, said plat being offered by Mattamy Palm Beach, LLC as owner, and title holder of said property and as prepared by David P. Lindley, as designated on the attached said Plat.

<u>Section 3</u>. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

<u>Section 4.</u> Conflicts. If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 5.</u> <u>Severability</u>. The provisions of this Resolution are intended to be severable.
