AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE PARTIAL ABANDONMENT AND TERMNATION OF A BLANKET FLOWAGE EASEMENT RECORDED IN OFFICIAL RECORDS BOOK 2902, PAGE 1220, OF THE PUBLIC RECORDS OF ST. LUCIE COUNTY, FLORIDA; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Horizons Acquisitions 5, LLC, a Florida limited liability company ("HA5"), conveyed that certain Blanket Flowage Easement to the City of Port St. Lucie ("City"), as depicted on the easement recorded in Official Records Book 2902, Page 1220, of the Public Records of St. Lucie County, Florida ("Blanket Flowage Easement"); and

WHEREAS, the Blanket Flowage Easement allows for temporary drainage flow from Becker Road over land owned by the City of Port St. Luce ("City") via existing agricultural ditches to the C-24 Canal; and

WHEREAS, the Blanket Flowage Easement is in place until permanent drainage facilities and easements are put in place as development occurs within the City owned lands; and

WHEREAS, the land that has been sold to Mattamy Homes, LLC, is adjacent to platted rights-of-way and water management tracts which will provide for the permanent conveyance of drainage from Becker Road to the C-24 Canal and thus, the Blanket Flowage Easement is not necessary on such land; and

WHEREAS, the City wishes to partially abandon and terminate the portion of the Blanket Flowage Easement situated on the real property that was sold to Mattamy Palm Beach, LLC, as set forth in the Partial Abandonment and Termination of Blanket Flowage Easement, which is attached hereto and incorporated herein as Exhibit "A".

NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:

<u>Section 1.</u> <u>Ratification of Recitals.</u> The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Ordinance.

Section 2. Authorization. That the Mayor, or her designee, or the City Manager, or his designee, are hereby authorized to execute any and all documents necessary to formalize and complete the partial abandonment and termination of the blanket flowage easement as contemplated herein, including but not limited to the Partial Abandonment and Termination of Blanket Flowage Easement in substantially the same form as attached hereto as Exhibit "A".

<u>Section 3.</u> Recordation. The City Council hereby directs that this Ordinance be recorded in the public records of St. Lucie County, Florida.

<u>Section 4.</u> <u>Conflict.</u> If any ordinances, or parts of ordinances, are in conflict herewith this Ordinance shall control to the extent of the conflicting provisions.

<u>Section 5.</u> <u>Severability.</u> The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

<u>Section 6.</u> <u>Effective Date.</u> This Ordinance shall become effective immediately after final adoption on second reading.
