The following modifications to the Terms and Conditions contained in Contract # 20190112 between American Consulting Engineers of Florida, LLC dated December 16, 2019 and the City of Port St. Lucie are hereby incorporated and made a part of that Contract.

1. This Amendment is to clarify and add additional scope of work to **TASK 6: UTILITY RELOCATION DESIGN** that the Contractor shall abide by. The scope of work is as follows:

TASK 1: PRELIMINARY DESIGN SERVICES (0-30%)

CONSULTANT will coordinate with Port St. Lucie Utilities (PSLU) to obtain as-builts of the existing watermain (WM), force mains (FM), low-pressure force mains (LPFM) and existing well collection lines along the corridor. Upon Receipt of the 30% plans, CONSULTANT will review the as-builts and prepare preliminary utility adjustment sheets to include plan and profiles. CONSULTANT will walk the site to identify any anomalies that may need to be addressed. All work included in this phase is preliminary in nature and is subject to change.

CONSULTANT to prepare a One-Call Design Ticket to identify all utilities located along the corridor. CONSULTANT to provide utility coordination with each identified utility and add utilities to the plans.

TASK 2: DESIGN DEVELOPMENT SERVICES (60%)

Upon receipt of the 60% plans, CONSULTANT will identify all conflicts with the stormwater design. CONSULTANT will recommend the potholing needed for the conflict areas. Upon receipt of the pothole information from the CLIENT, the CONSULTANT will coordinate with PSLU to resolve all conflicts identified. CONSULTANT will prepare utility adjustment plans as per the conflict resolutions. CONSULTANT will prepare well line plans. The CONSULTANT will attend meetings with PSLU and Florida Department of Environmental Protection (FDEP) water and sewer as needed. Additionally, the CONSULTANT will make applications for permits to the previously mentioned agencies. CONSULTANT will do 60% quantities and probable engineer's cost for the identified conflict resolutions.

CONSULTANT to provide utility coordination with utilities identified in Task 1 to verify utility location.

TASK 3: FINAL DESIGN SERVICES (90%)

Upon completion of 60% plans, CONSULTANT will coordinate utility meetings with the City of Port St. Lucie Engineering Dept., American Consulting Professionals, LLC and CAPTEC.

The 90% final utility adjustment sheets will include plan and profiles, conflict details, and utility details. At completion of this phase, the FDEP water and sewer will be prepared as applicable.

TASK 4: ISSUED FOR CONSTRUCTION (IFC) PLANS & BID DOCUMENTS (100%)

CONSULTANT will include complete design, permit, and City Staff comments for construction of the City of Port St. Lucie Utilities. This phase will include preparation of contract documents, which will include final quantities and technical specifications for Segments 2 and 3 for bidding purposes. This phase will also include pursuing all permits to completion.

Upon completion the Engineer shall submit signed & sealed 100% "Issued for Construction" Plans, Final Cost Estimates, Utility Coordination documentations, and any necessary permitting documentation and any applicable permits.

TASK 5: PERMITTING SERVICES

CONSULTANT will conduct pre-application meetings, make applications for permits authorizing activities associated with the watermain, force main, well collection lines and the low-pressure force main relocations along the Floresta Drive corridor to PSLU and FDEP.

CONSULTANT will prepare permit applications for the above listed permits for submittal to the permitting agencies. Engineer will submit permits to and respond to requests for information (RFIs).

The CONSULTANT will process the permits on behalf of the City and seek to obtain the permits expeditiously.

2. Amendment #1 shall not add any additional cost.
3. Amendment #1 shall not add any additional calendar days.
4. All other terms and conditions of the original contract and/or Addenda apply.
