**8.a** Ordinance 22-11, Public Hearing, An Ordinance Amending Chapter 158, Section(s) 158.221 & 158.222 (Driveway Standards) Text Amendment (P21-098)

The Assistant City Clerk read Ordinance 22-11 aloud by title only. (Clerk's Note: A PowerPoint was shown at this time.) Bethany Grubbs, Planner II, explained that the item was requesting that circular driveways be installed for single family lots on streets with more than two lanes and ones that are deemed to be potentially hazardous; it also increased the driveway width. If the circular driveway was not viable per the Public Works Department, a 10 by 20-foot paved turn around area would be permitted. She explained the width increases and the secondary driveway allowance. She added that the Planning & Zoning Board had recommended approval. She explained to the City Council

that driveways could be constructed of asphalt, concrete and brick pavers, a portion of the secondary driveway could be constructed of millings or stabilized grass. Councilwoman Morgan inquired as to whom deemed the streets as a potential hazard, to which Ms. Grubbs replied that it would be the Public Works Department. Councilwoman Morgan had questions on certain streets and questioned as to how many infill lots there were. Deputy City Manager Lamar-Sarno replied that she would meet with Councilwoman Morgan to address her concerns.

Mayor Martin opened the Public Hearing and asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed. There being no further discussion, Vice Mayor Caraballo moved to approve Ordinance 22-11. Councilman Pickett seconded the motion. Under discussion, Vice Mayor Caraballo clarified that this item was related to new builds only. The Assistant City Clerk restated the motion as follows: for approval of Ordinance 22-11. The motion passed unanimously by roll call vote.

The Assistant City Clerk read Ordinance 22-17 aloud by title only. Mayor Martin opened the Public Hearing. The City Manager explained that the City was in the process of acquiring the 20 acres & were closing out certain tax issues related to the property. Mayor Martin asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed.

There being no further discussion, Councilwoman Morgan moved to approve Ordinance 22-17. Councilman Pickett seconded the motion. The Assistant City Clerk restated the motion as follows: for approval of Ordinance 22-17. The motion passed unanimously by roll call vote.

#### 10. First Reading of Ordinances

**10.a** Ordinance 22-18, An Ordinance Approving the Second Amendment to the Becker Road Overlay District Design Standards (P21-202).

2022-037

The Assistant City Clerk read Ordinance 22-18 aloud by title only. (Clerk's Note: A PowerPoint was shown at this time.) Holly Price, Planner III, stated that the Becker Road Overlay District extended between the Turnpike and I-95 and the goal was to create an attractive corridor for pedestrians and motorists since it was a gateway for the City. She reviewed the previous concerns/directions of the City Council: limit the fueling stations, allow drive-throughs on B street, 35-45ft landscape buffer in activity center & 25-35ft buffer in conversion areas, 50 x 50 square feet corner plazas, heavily screen parking lots & fueling station canopies with landscaping, restrict vehicular access to the Activity Center District from Becker Road & Port St. Lucie Boulevard

without approval of a Special Exception Use. Mayor Martin voiced that she would not support access to residential streets. Mr. Stocton explained that access on the lower volume roads were the safest as there could be issues on higher volume roads. Ms. Price stated that another direction of City Council was to reduce parking requirements, staff had reduced restaurants, drive-throughs and outparcels parking by 25%, convenience stores with fueling stations parking by 20%, shopping center parking by 10%, and office space parking by 10%. She stated that the City Council had encouraged public-private partnerships to landscape the City owned pond and the proposed code required that developers provide landscaping near the pond since legal was unsure if the City could require owners to provide landscaping around the City pond. Deputy City Manager Lamar-Sarno added that talks with developers seemed positive. She stated that the Planning & Zoning Board had made recommendations and altered staff's recommendation a bit which the consultant would explain.

(Clerk's Note: A PowerPoint was shown at this time.) Michael Houston, Civic Plan Studio, explained the current concerns: frontage landscape buffer dimensions, permitted locations & drive lane locations for fast food drive-throughs and the parallel sidewalk requirement. Under issue number one, frontage landscape buffer, he explained that staff had recommended a 35-45ft buffer to be measured from the property line and corner greens measuring 80 x 80 & the Planning & Zoning Board had recommended reducing the landscape buffer to 30-40ft and corner greens measuring 50 x 50. He felt that reducing the buffers would still keep the geometry of the property, but the developers may need to install corner treatments if those greens were reduced. Under issue 2A, permitted drive-through locations, he explained that staff had recommended only allowing them on B street (not Becker Road) which would not include pharmacies and banks. He stated that the Planning & Zoning Board had recommended drive-throughs on both Port St. Lucie Boulevard and Becker Road. He stated that if the Planning & Zoning recommendation was chosen, it would not regulate where the fast food locations would be and potentially be five or six along the street. Under issue 2B, fast food drive lanes in the front of buildings, he explained that staff had recommended no lanes/windows on the front of buildings and the Planning & Zoning Board had recommended drive lanes/windows on the front side of buildings with additional landscaping. Under issue three, parallel sidewalk, he explained that staff had recommended an additional sidewalk to provide safety for pedestrians, which the Planning & Zoning Board had agreed on staff's

recommendation. Ms. Price reiterated staff and City Council's recommendations and concerns. She stated that staff had recommended that buildings be parallel and allow the drive-through windows on the back of the building.

Councilman Pickett inquired as to why two sidewalks were recommended, to which Ms. Price replied that the current sidewalk could be used for multimodal, and the additional sidewalk could be used mostly for pedestrians. She stated that it was a safe practice to have something between the vehicles and the pedestrians. Mayor Martin voiced that the City was moving more towards safe sideways and had to make changes to ensure proper planning. Vice Mayor Caraballo inquired as to how the additional sidewalk would be integrated with the current sidewalk, to which Ms. Price replied that there would be cross connection and that currently two sidewalks were required within the City. Deputy City Manager Lamar-Sarno stated that staff was looking at long-range planning and took the City Council direction of "doing something different".

Dan Sorrow, Cotleur & Hearing, showed a presentation and made five requests: allow drive-throughs along Becker Road, allow drive-through lanes between the building and Becker road, allow them also between Port St. Lucie Boulevard and the building, reduce the building frontage along Becker Road to 30% and reduce the building frontage along Port St. Lucie Boulevard to 20%. Ms. Price stated that it was staff's discretion and a case by case item, but there was design relief that would allow a 10% reduction for the building frontage. Deputy City Manager Lamar-Sarno added that it could be done in tandem so that it did not delay the process.

Marc Offit, Braden Realty, thanked staff for their cooperation with this item and reviewed Mr. Sorrow's PowerPoint. He stated that they were asking for the ability to add a drive-through to the ends of the multi-tenant buildings and added that if the drive-through lanes were on the side the pedestrian would be crossing the lane which would not be safe.

Brad Currie, Engineering, Design & Construction, showed a presentation & requested to streamline the presentations and information on this topic. He stated that his outstanding concern was the west side of Port St. Lucie Boulevard since he was unsure if having an additional sidewalk there would be useful.

It was the consensus of the City Council to accept the Planning & Zoning Board's recommendation on the frontage landscape buffer dimensions (reducing it to 30-40ft & corner greens 50 x 50); allow only one drive-through on each frontage, Becker Road and Port St. Lucie Boulevard, not including grocery/pharmacy, and allow the drive-throughs to face the road with heavy landscaping; accept staff's & Planning & Zoning Board's recommendation to allow for the additional sidewalk; allow for design relief and requested to hold one on one meetings with staff and the applicants to discuss side street access prior to the Second Reading.

There being no further discussion, Councilwoman Morgan moved to approve Ordinance 22-18. Councilman Bonna seconded the motion, which passed unanimously by voice vote.

A break was called at 9:06 p.m., and the meeting resumed at 9:16 p.m.

The City Attorney stated that he needed to provide a WastePro litigation update to the City Council. There being no further discussion, Councilman Pickett moved to approve Item 13 b). Councilman Bonna seconded the motion, which passed unanimously by voice vote.

#### 14. City Manager's Report

The City Manager informed the City Council that City resources were picking up yard waste throughout the City and the drop off site was open seven days a week. He stated that vaccine pods would be discontinued since the demand was very low. He provided an update regarding large items that were going through Site Plan Review.
