

Small Business Assistance Program

The Mission: The Small Business Assistance Program of the St. Lucie County Chamber of Commerce helps businesses navigate the regulatory process. Our purpose is to minimize cost, risk and time delays when local business seeks to purchase, build, expand, relocate or repurpose commercial space.

Contact: 2024 has been an especially busy year for the Small Business Assistance Program as we have seen 75 unique clients between January and August. This is an average of over 9 clients per month. As contact with individual clients is not singular in nature, we have had approximately 125 individual contacts. This equates to nearly 4 contacts weekly. In addition, we have on-boarded 132 New members since January. These businesses, by virtue of seeking membership, are looking for some sort of business assistance whether it be for networking, advocacy or guidance. The conversion rate of SBAP clients to members is generally very low so the new members represent several unique additional clients.

Types of Businesses: We are still seeing inquiries about schools. However, this is beginning to slow as we continue to education on the special needs of structures housing schools. We have seen an uptick in unique businesses attributed to trends. Several, rentable display trucks with no attached services, bar carts without the provision of alcohol and even microgreen businesses have come in for consultation.

Insights: The clientele seems to be skewing younger although age data is not collected, this is observation only. This could be what is attributing to the influx of niche and unique business inquiries.

We continue to encourage all operators to contact us at their initial stage of entry into the regulatory system. When this happens we see users have a greater rate of success in navigating the system. However, we still get the occasional applicant who has presented inaccurate descriptions of their business or categorized themselves incorrectly. The process to get this rectified has become less arduous at all jurisdictions. However, the new policy of having to sign-in/create an account to complete the business tax receipt application has become problematic and is counter-productive to the goal of heading off missteps before they are taken.

Outreach: Word of mouth and referrals from local jurisdictions continue to be the best form of outreach. In areas where workshops are currently taking place, we do see more usage. Given this, we have entered into an agreement to bring Mr. Wooten's idea of "Before You Sign the Lease" workshops to St. Lucie County as well.
