#### **RESOLUTION 25-R**

A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA, APPROVING THE NAME TORINO REGIONAL PARK FOR THE REGIONAL PARK SITE LOCATED AT 5301 NW NORTH TORINO PARKWAY, PORT ST. LUCIE, FLORIDA; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** a conceptual master plan for the Torino Regional Park site was developed through meetings with City staff, the public, and stakeholder groups, referencing the City's Parks and Recreation 10-Year Master Plan; and

**WHEREAS,** on June 24, 2024, the City Council approved the Torino Regional Park Conceptual Master Plan and Phase 1 Funding and Phasing Recommendation for the park site located on 5301 NW North Torino Parkway, Port St. Lucie, Florida; and

**WHEREAS,** an amended design contract with Kimley-Horn was approved on October 28, 2024, followed by a Construction Manager at Risk contract with Burkhardt Construction, Inc. for preconstruction services on November 12, 2024, to implement Phase 1 improvements; and

**WHEREAS**, the general location of the park is depicted on Exhibit "A" attached hereto and incorporated herein; and

**WHEREAS,** on July 14, 2025, the City Council approved staff proceeding to 90% design; and

**WHEREAS**, the site has been referred to as "Torino Regional Park" during planning and design phases; and

WHEREAS, the City Council now desires to officially approve the name "Torino Regional Park" for the site located at 5301 NW North Torino Parkway, Port St. Lucie, Florida; and

**WHEREAS,** this action is consistent with City Council Directed Policy #19-04ccd, the Naming Policy for City Facilities.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1. Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2.</u> <u>Official Park Name.</u> The City Council approves the official name of the park site located at 5301 NW North Torino Parkway, Port St. Lucie, Florida as **Torino Regional Park**.

<u>Section 3.</u> <u>Conflict.</u> If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.
