

**CITY OF PORT ST. LUCIE**  
**SITE PLAN REVIEW COMMITTEE MEETING MINUTES**  
**January 14, 2026**

**1. CALL TO ORDER**

A Regular and Virtual Meeting of the SITE PLAN REVIEW COMMITTEE of the City of Port St. Lucie was called to order by Chair Cox on January 14, 2026, at 1:30 p.m. at Port St. Lucie City Hall, Building B, Training Room, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida and via Zoom.

**3. APPROVAL OF MINUTES –November 12, 2025**

Mr. Glover **moved** to approve the minutes. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**4. ADDITIONS AND/OR DELETIONS**

Dan Robinson, Planner III, added P19-067-A1 Decorative Concrete, Major Site Plan Amendment to the agenda. Sofia Trail, Planner I, edited P25-210 as it did not include Construction Plans but included Landscape Plans. Bethany Grubbs, Senior Planner, added P25-019 Tradition Coffee Rush @ The Landing, Minor Site Plan & Construction Plans. Cody Sisk, Planner III, removed P02-359-A2, SLW-Raw Athletics Minor Site Plan Amendment Landscape.

Mr. Glover **moved** to approve the amended agenda. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**6. REVIEW OF DEVELOPMENT PROJECTS**

**P25-210 Southern Grove-SG8 Multi-Family Northern Parcel Major Site Plan Landscape Plans**

Derrick Phillips, Lucido & Associates, represented the applicant. Due to staff's concerns they recommend tabling the item.

Mr. Glover moved to table P25-210, Southern Grove-SG8 Multi-Family Northern Parcel Major Site Plan, Landscape Plans. Ms. Zsoka seconded the motion, which passed unanimously by voice vote.

**P25-211 Southern Grove Wawa Fuel Station & Convenience Store Minor Site Plan, Construction Plans**

Kevin Velinsky, Lucido & Associates, represented the applicant.

Mr. Glover **moved** to approve P25-211, Southern Grove Wawa Fuel Station & Convenience Store Minor Site Plan, Construction Plans with all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**P24-019 JJF Automotive Shoppe Construction Plans**

Abraham Chabab represented the applicant. Due to staff's concerns regarding catch basins & elevations, they recommended tabling the item.

Mr. Glover **moved** to table P24-019, JJF Automotive Shoppe Construction Plans. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**P25-182 PSL Contractor Storage Resubmittal Minor Site Plan Construction Plans**

Drew Wishman, Kimley Horn, represented the applicant. Staff and the applicant clarified some concerns over the comments and decided to have an offline meeting.

Mr. Glover **moved** to approve P25-182, PSL Contractor Storage Resubmittal Minor Site Plan, Construction Plans with all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**P02-359-A2 SLW-Raw Athletics Minor Site Plan Amendment Landscape**

**P17-051-A1 Southern Grove Wawa Tesla Electric Vehicle Charging Station Resubmittal Construction Plans**

Nathan Kreuser, Dewberry Engineers, represented the applicant.

Mr. Glover **moved** to approve P17-051-A1, Southern Grove Wawa Tesla Electric Vehicle Charging Station Resubmittal, Construction Plans with all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**P25-023      Southern Grove America Walks Parcel “C” Construction Plans**

Sarah Dowling, GBD Group, represented the applicant. Acting Chair Kean clarified that the Construction Plans pertained to the Panda Express. She advised the applicant that the Site Plan remained under review and that any changes impacting the Construction Plans would require returning to the Committee.

Mr. Glover **moved** to approve P25-023, Southern Grove America Walks Parcel “C” Construction Plans with all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

**P25-019 Tradition Coffee Rush @ The Landing, Minor Site Plan & Construction Plans**

Jonny Harris, Kimley Horn, represented the applicant. Due to staff’s concerns over queuing, they recommended tabling the project.

Mr. Glover **moved** to table P25-019, Tradition Coffee Rush @ The Landing, Minor Site Plan & Construction Plans. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.
