This CONTRACT executed this _____ day of _____, 2025, by and between the CITY OF PORT ST. LUCIE, FLORIDA, a municipal corporation, duly organized under the laws of the State of Florida, located at 121 SW Port St. Lucie Blvd., Port St. Lucie, FL 34984, hereinafter called "City", and STREET SMART RENTALS, LLC, a foreign limited liability company, located at 6811 137th Ave. NE, Columbus, MN 55025, hereinafter called "Contractor." The City and Contractor may be referred to individually as a "party" or collectively as the "parties."

**SECTION I
RECITALS**

In consideration of the below agreements and covenants set forth herein, the parties agree as follows:

WHEREAS, Contractor is registered to conduct business in the State of Florida; and

WHEREAS, the City wishes to contract with a contractor for the purchase of portable traffic signals based on the terms and subject to the conditions contained herein; and

WHEREAS, Contractor is qualified, willing, and able to provide the products/services specified on the terms and conditions set forth herein; and

WHEREAS, the City desires to enter into this Contract with Contractor to perform the products/services specified and, with a commission amount to be paid as agreed upon herein.

NOW THEREFORE, in consideration of the premises and the mutual covenants herein name, the parties agree as follows:

The Recitals set forth above are hereby incorporated into this Contract and made a part hereof for reference.

**SECTION II
PRODUCTS AND PRICES**

The items City may purchase under this Contract, including the corresponding prices, are listed in the Contractor's Rental Quote: 303969 ("Contractor's Quote"), which is attached hereto and incorporated herein. Contractor's Quote is made part of this Contract, except that the following sentence is removed, and therefore does not apply: "Client to provide insurance certificate naming Street Smart Rental, LLC as loss payee."
