#### 2. DICKERSON / CASE NO. 24-17801 / 1500 SE VILLAGE GREEN DR

Code Compliance Officer Dickinson read the case presentation and Staff's recommendations into the record and presented photos that were taken at the time of the inspections showing the subject property and violations. Code Compliance Supervisor Wesley Armstrong provided a background and stated that the Respondents were in talks with the City to turn the area into an access point, but the talks have ceased, so it would have to be turned back into the required parking. Acting Supervisor Catherine Laird then informed that she spoke to the property owner the previous morning.

The Deputy City Clerk swore in Todd Mowry, RedTail, who represented the Respondent. He informed that the Site Plan was outdated and that they met with City Staff to get into compliance. He also informed that the City was going to buy the property located next to this one, and they broke the concrete, but the owner did not want to ask them to fix it, so he would repair it himself. He requested a 60-day extension. The Special Magistrate inquired if anyone in the City had a response to the testimony that the City damaged the concrete and if anyone disputed this, to which Supervisor Armstrong replied that the department was not notified of anything. He also noted that the parking issue had always been there but was not addressed at the time that the City was looking to acquire the property. The Special Magistrate stated that City Codes 158.211 and 158.221(h)(2) had been abated, and the only violation he would find would be for the Site Plan, 158.237(c)(8).

The Special Magistrate found proper notice and based on the testimony and evidence reviewed, he found the property remained in violation as cited and ordered a compliance deadline by September 10, 2025.

## 7. HERZOG / CASE NO. 25-07349 / 243 SW STATLER AVE

Code Compliance Officer Herzog read the case presentation and Staff's recommendations into the record and presented photos that were taken at the time of the inspections showing the subject property and violations. He noted that this case had the same issues since 2016 and the case was brought up again because the old one maxed out on the lien.

The Deputy City Clerk swore in Stephanie DeSanti, who represented the Respondent. She stated that someone was coming to put siding on the house and rebuild the front next week, and that they currently did not have the money to fix the garage door.

The Special Magistrate continued the case to August 20, 2025.

#### 10. HUCKSTABLE / CASE NO. 23-04038 / 473 SE EVERGREEN TER

Code Compliance Officer Huckstable read the case presentation and Staff's recommendations into the record and presented photos that were taken at the time of the inspections showing the subject property and violations. The Deputy City Clerk swore in Kelly Forbes who stated that she was having an insurance issue and her attorney would be filing suit against them.

The Special Magistrate continued the case to November 12, 2025.

The Deputy City Clerk swore in Jeffrey Miller who stated that his property was highly maintained and felt that the original trees had destroyed his parking lot. He wanted to work with the City on planting a different species. He stated that hedging blocked his property, which was in a retail/commercial corridor, was not a productive method.

The Special Magistrate found that proper notice was achieved, and that the property remained in violation. He set a compliance date for October 15, 2025.

The Deputy City Clerk swore in Reynaldo & Vilma Lima who stated that they had financial issues and could not insure the truck or pay for registration. City staff stated that the truck could be placed in the garage.

The Special Magistrate found that proper notice was achieved, and that the property remained in violation. He set a compliance date for October 15, 2025.

(Clerk's Note: A PowerPoint was shown at this time.) Code Officer Diaz, previously sworn, read the case presentation and staff's recommendations into the record. She presented photos that were taken at the time of the inspections showing the subject property and violations.

The Deputy City Clerk swore in Rosie Baret who stated that the association held meetings regarding the property's landscaping, irrigation, etc., which the tenants had to pay into. She added that her window had been changed three times. She questioned why her window was in violation since the properties next to her had dark mirror tint on the window; she felt that she was targeted.

The Special Magistrate replied that he had numerous cases on agendas every week therefore he could not believe a specific property was targeted. Catherine Laird, Code Compliance Officer II, informed the Special Magistrate that the violation was complaint based & added that signage was mentioned in the ordinance, tint was not included.
