

#### **NEIGHBORHOOD PLANNING HISTORY**

- 2004 Urban Land Institute hired to study the City's rapid growth and future needs (Housing needs, employment opportunities, infrastructure needs, schools, parks, libraries, public safety, entertainment)
- 2015 Planning & Zoning Department hired a consultant to begin the neighborhood planning process.
  Plans were developed for six Planning Areas.
- Focused on: Building Identity, Activity Centers, Recreation and Leisure, Connectivity, Arts and Culture.
- August 8, 2016 Neighborhood Services was created and tasked with plan implementation.

#### **N.I.C.E. PROGRAM BEGINNING**

- Establishment of the Neighborhood Improvement & Community Engagement (N.I.C.E) Program.
- N.I.C.E. Program funded by proceeds derived from the City's curbside recycling program.
- These dollars are then invested back into our neighborhoods in accordance with the neighborhood plans. This subsequently allows for the implementation of neighborhood improvements for all residents within the City to enjoy.





#### INTERDEPARTMENTAL COORDINATION AND PARTNERSHIPS

- Neighborhood Services Department (NSD) staff held Unfunded Needs meetings with various City Department's throughout the month of September 2021 to determine unfunded priorities for FY 2022-23.
- Interdepartmental coordination and evaluation for FY 2021-22 project selection previously occurred in Fall 2020.
- Projects selected for NICE funding were evaluated and selected based on the following: Existing budget; Previous public input received; and how they align with the recommendations from the approved Neighborhood Action Plans.






# DECORATIVE STREET SIGNS & POLE RETROFIT

#### Becker Road

- **\$150,000**
- Furnish & Installation to be performed by awarded contractor.
- Project limit includes from I-95 to Florida's Turnpike.
- Estimated 45 poles required.

# DECORATIVE STREET SIGNS & POLE RETROFIT (CONT.)

#### **FY2023**

#### Gatlin Boulevard

- **\$75,000**
- Furnish & Installation to be performed by awarded contractor.
- Project limit includes from I-95 to Port St. Lucie Boulevard.
- Estimated 20 poles required.


#### Bayshore Boulevard

- **\$75,000**
- Furnish & Installation to be performed by awarded contractor.
- Project limit includes from Port St. Lucie Boulevard to Crosstown Parkway.
- Estimated 24 poles required.

#### Floresta Drive

- \$60,000
- To be performed as part of Floresta Drive Improvement Project Phases 2-3

## UTILITY BOX WRAP PROGRAM (CITY-WIDE)

FY2022 & 2023

### FP&L Privately-Owned Utility Boxes

- **\$20,000**
- All utility boxes in public right-of-way have been wrapped as of 2020.
- FP&L agreed to allow their utility boxes located in public places be wrapped. The City must administer the application program.

# ST. LUCIE WEST BLVD. – SPECIAL PURPOSE PROJECT – PEDESTRIAN AMENITIES


#### **FY2022**

#### St. Lucie West Boulevard Corridor

- \$55,000 (\$16,000 Resident Contribution)
- Project will include the purchase and installation of 10 benches and 10 receptacles along St. Lucie West Boulevard.
- I 0 concrete pads will be poured to allow for placement of benches with adequate room for pedestrians traveling along the sidewalk.

- **\$50,000**
- Durango Street
- Floresta Drive

#### Typical Cedar color bench with green frame




### PARK FITNESS EQUIPMENT

#### **FY2023**

### Charles Ray Park

- N.I.C.E. contribution \$50,000
- Fitness equipment to accompany new playground installed in 2021.
- Limited park fitness equipment exist in the northern portion of the City.
