WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1A.

A Contract Extension. The parties hereby agree that the contract will be extended for an additional period of time as follows:

Beginning Date of Amendment #1 December 1, 2023. End Date of Amendment #1 November 31, 2028.

- B. The parties agree the contract will expire at midnight on the date defined as the "End Date of Amendment #1 Term" unless the parties agree to extend the contract for an additional two years.
- 1B. Quantity for Flock Safety LPR Products shall change from 14 to 23. This Agreement includes and incorporates the previously executed agreements on i) January 28, 2022; ii) June 21, 2022; and iii) August 22, 2023, for a total of twenty-three (23) Flock Safety Falcon devices.
- 1C. The annual subscription rate will increase from \$35,000 to \$57,500. This reflects an unchanged unit price of \$2,500 oper camera.
 - 2. **SUCCESSORS AND ASSIGNS.** This Amendment shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.
 - 3. **ENTIRE AGREEMENT.** Except as expressly modified by this Amendment, the contract shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment and the contract (including any written amendments thereto), collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
