St. Lucie Habitat for Humanity request reimbursement from the City's Affordable Housing Trust Fund for the cost of impact and permitting fees for an affordable home located at 822 SW Harvard Road in the City of Port Saint Lucie. This affordable home is to be sold to a household earning 80% or less of AMI and the sale will utilize our Land Trust ground lease to insure this affordability beyond the first owners.

Attached is documentation of our direct cost of permitting and impact fees totaling \$26,714.42. Recovering this cost will increase the additional affordable homeownership opportunities that we can provide within the City. These funds can advance the creation of a sustainable inventory of affordable homeownership opportunities in the City.
