had found a Florida foundry based in Miami to finish the piece. Vice Chair Lee inquired about landscaping, to which Mr. Hass replied that landscaping would be minimal so that it did not overshadow the piece but added that there would be lighting. The board inquired about a bench or lake access to which Mr. Hass replied that he could look into installing a bench but there was no real lake access. Vice Chair Lee moved to recommend approval of the sculpture for the Lake Whitney Place at St. Lucie West to the City Council. Ms. Zinn seconded the motion, which passed unanimously by voice vote.
