WHEREAS, the Contract is in effect through the Current Contract Term as defined above; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1A. New electrical receptacles have been added to the breakroom which requires the installation of a new electrical subpanel due to lack of available circuit breaker space in the existing electrical panel.
- 1B. Installation of recess light and exit light in stair vestibule.

- 1C. An existing wall being removed inside the locker room has four (4) electrical conduits in it which are fed from under the floor slab that need to be re-routed above the ceiling to the electrical panel in the electrical room to maintain the light fixtures and receptacles they are serving. The existing conduits will be removed to facilitate the wall removal.
- 1D. An additional 58 calendar days are required for the additional scope of work.
