



Business Accelerator Program

• The ten-week course is offered by IRSC and the Florida SBDC provides the instructors. Over the past six years 156 businesses attended and 100 completed the program.

Small Business Grant Program

• Port St. Lucie businesses that complete the Business Accelerator Program are eligible to apply for a small business reimbursement grant up to \$5,000. Over the past six years we have awarded \$164,000 in small business grants to Port St. Lucie businesses.

- The next "Before You Sign the Lease" workshop will be held on July 25, 2023 at11:00 am in Training Room of Building B.





DEO CDBG-CV Small Business Grant



- The City was awarded \$423,707 through the CDBG-CV program to provide grants to business impacted by the COVID-19 pandemic.
- The Florida Small Business Development Center will provide the grant review.
- Businesses that experienced a 20% reduction in revenue due to the COVID-19 pandemic are eligible.
- The business must be located in a low-to-moderate income census tracts or the business owner's household income is certified as low-to-moderate income are eligible to apply.
- The grant will provide up to \$10,000 to reimburse mortgage/lease payments, utility and insurance premium costs, payroll during business closure, reopening costs and safety measures.

Business Tax Workshops (In-Person and Virtual)

Business Tax conducts FREE business training workshops to existing, new, and relocating businesses in the city. Each workshop is approximately 90 minutes in length and covers a variety of topics, including accounting, finance, international business, logistics, marketing, contracting, and more.

The workshops can address prevalent challenges and difficulties business professionals face daily. Participants can share their ideas and views on tackling problems, which can provide a new prospective on how to address it.
