The City Clerk read Ordinance 21-46 aloud by title only. Mayor Martin opened the Public Hearing.

(Clerk's Note: A PowerPoint was shown at this time.) Bridget Kean, Senior Planner, explained that this item was the Adoption Hearing for the Large Scale Comprehensive Plan Text Amendment. She said that the property was located west of I-95, south of Tradition Parkway, north of Becker Road and east of SW Community Boulevard. She explained the proposed changes to the land in the subdistricts in Southern Grove. She said that the completed traffic analysis was reviewed and showed that the changes in entitlements would not impact transportation. Vice Mayor Caraballo stated that these proposed changes would provide for higher wage jobs. Councilman Pickett inquired about the removal of the Paar Drive overpass, to which Ms. Kean replied that the changes did not remove the potential for a third interchange, and they did not want the truck traffic passing over Paar Drive. Councilman Pickett inquired if they could keep the overpass open and restrict the truck passage, to which Ms. Kean replied that the area was proposed for development. Mayor Martin stated that Rosser Boulevard in that area was highly residential and would be disrupted. The City Manager stated that the original DRI included a regional mall, and since it was removed the trips were reduced.

Steve Carroll spoke regarding the use of the area and the negative aspects of growth for the City. He inquired if the property was inspected for protected animals. Mayor Martin asked if there was anyone else who wished to speak on the item, to which there was no one, therefore the Public Hearing closed.

Vice Mayor Caraballo moved to approve Ordinance 21-46. Councilman Pickett seconded the motion. The City Clerk restated the motion as follows: for approval of Ordinance 21-46. The motion passed unanimously by roll call vote.

Carmen Capezzuto, Neighborhood Services Director, stated that this was a requirement to apply for CDBG-CV Coronavirus Round 2 funding which was a competitive process which would be run through the Business Navigator's Office. Elijah Wooten, Business Navigator, explained that the City would be applying for a \$1.5 million grant through the DOE to supply support to businesses that were impacted by the pandemic. He stated that it was tied through CDBG funding for businesses in low-moderate income areas.

There being no discussion, Councilwoman Morgan moved to approve Resolution 21-R133. Vice Mayor Caraballo seconded the motion. The City Clerk restated the motion as follows: for approval of Resolution 21-R133. The motion passed unanimously by roll call vote.

11.9 Resolution 21-R134, A Resolution to Approve a Ten-Year Ad Valorem Tax Exemption for Fed Ex Facility

2021-891

The City Clerk read Resolution 21-R134 aloud by title only. The City Manager stated that a referendum would take place on December 7th, to renew time limited tax abatement to attract major employers to the City. He said that this resolution would allow for Fed-Ex to receive the tax abatement.

Steve Carroll voiced his concerns about the Ad-Valorem Tax exemption. The City Manager explained that for a company to be eligible for the tax exemption they had to make a substantial capital investment and/or employ full time employees that make above average wage in the community; all the information would be verified. If they did not meet the threshold the company did not receive the abatement for the year. He said that he believed Fed-Ex would be supplying \$34 million not including interior machinery. He said that the City had allowed for abatements up to 5-years then began to phase in

the taxes. He clarified that only two entities could provide the abatement, and this item referred to the City's ad-valorem tax abatement. He added that it was the only incentive in the State of Florida for economic development and most large counties/cities in the state used the same tool.

Vice Mayor Caraballo moved to approve Resolution 21-R134. Councilwoman Morgan seconded the motion. The City Clerk restated the motion as follows: for approval of Resolution 21-R134. The motion passed by roll call vote with Mayor Martin, Vice Mayor Caraballo, and Councilwoman Morgan voting in favor and Councilman Pickett abstaining from the vote.

11.h Resolution 21-R135, A Resolution Approving the Preliminary and Final Plat for Riverland Parcel C - Plat Eight Replat (P21-196)

Vice Mayor Caraballo- On October 14th she attended River Nights; she voiced that parking would need to be addressed & how to spread out the event along the boardwalk. On October 20th she attended a Treasure Coast Regional League of Cities Meeting, Florida League of Advocacies meeting, and a Historical Society gathering for the referendum. On October 21st she toured the Fed-Ex site. On October 23rd she attended the Chili Cookoff.
