QUIT CLAIM DEED

Together with all and singular the tenements, hereditaments and appurtenances belonging to or in anywise appertaining to that real property.

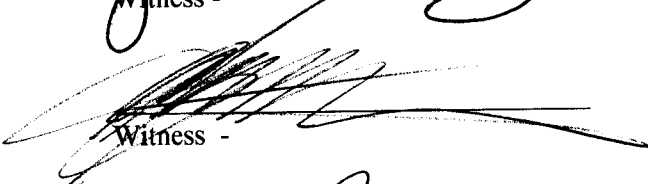
