To All:

I want to comment on the proposal by the P&Z Board to only handle small projects and change the City Code; I strenuously object.

Why? the members of the P&Z Board are appointed by each member of the City Council. While I am gratified that the current City Council is far more informed than previous Councils, the members of the P&Z Board are not qualified. There seems to be no set standard of criteria for their backgrounds and I have found that many times they don't bother to inform themselves of events, rules, issues.
