Background: While under contract with E.K. Phelps, the Utility Systems Department began purchasing Flygt pumps to be use throughout the City. Flygt was then purchased by Xylem Water Solutions USA, Inc. Xylem is now the sole provider of Flygt products and services as well as the only authorized service repair and warranty organization in the State of Florida. The staff is properly trained to provide original equipment, spare parts, repairs and warranty service.

Issues/Analysis: Staff has reviewed the current price list and finds that it is acceptable. Flygt products have been used throughout the City since 1995. The Sole Source memo was posted on Demandstar for seven (7)
