Mistake: Thinking you need an exuse to vote by mail

Solution: Unlike voters in some other tates, Floridians don't have to provide a eason for requesting a mail ballot, vhich used to be commonly called "abentee" ballots.

Whether your work hours prevent ou from getting to the polls or you simply don't feel like waiting in line to cast your vote, it's your right to request a mail ballot.

## Receiving a mail ballot

Mistake: Ballot mailed to incorrect address

Solution: Unless you inform your county's elections office otherwise, your ballot will be mailed to the residential address on file.

conege students, for example, should request ballots be sent to their dorms instead of their parents' homes.

State law prohibits absentee ballots from being forwarded, so not updating your mailing address will delay and may impede your ability to vote by mail.

Mistake: Opening the wrong mail ballot

Solution: When expecting a ballot, it's human nature to tear it open as soon as you see the "Official Election Mail," but you best make sure the envelope is addressed to you, not a neighbor or another voter in your home...

If you accidentally open someone else's ballot envelope, contact your elections office.
