1. Meeting Called to Order

A Regular Meeting of the CITY COUNCIL of the City of Port St. Lucie was called to order by Vice Mayor Caraballo on January 10, 2021, at 6:31 p.m., at Port St. Lucie City Hall, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida.

3. Invocation & Pledge of Allegiance

Vice Mayor Caraballo led the assembly in the Pledge of Allegiance.

4. Proclamations and Special Presentations

4.a Proclamation: Dr. Martin Luther King, Jr. Day

Vice Mayor Caraballo read the Proclamation and proclaimed January 18, 2022 to be observed as Dr. Martin Luther King, Jr. Day. She presented it to Kelly Tiger, Special Events Administrator of Parks & Recreation, and Ms. Tiger announced that the Dr. Martin Luther King, Jr. Fun Day would be held on January 17, 2022.

4.b Proclamation: Arbor Day [2021-1076](#)

Vice Mayor Caraballo read the Proclamation and proclaimed January 21, 2022 to be observed as Arbor Day. She presented it to Judith Sekscenski, Chair of Keep Port St. Lucie Beautiful, and Jeffrey Chambers, President of the Port St. Lucie Botanical Gardens. Chair Sekscenski informed the Board that Port St. Lucie had been awarded the Tree City U.S.A designation for 17 years and had received the Growth Award Recognition for 16 consecutive years, with over 16,000 trees being planted in 2021 and 70,495 trees since the inception of the Tree Challenge. Mr. Chambers invited the Board to the Arbor Day Celebration on January 21st, and announced this year's tree to be a Weeping Bottlebrush. He stated that the number of visitors for the year was 134,932, and announced the labor hours and wages.

City Manager Blackburn stated that he had previously provided a recommendation to table this item to a future date, but that based on revisions made, he no longer wished to table the item and Vice Mayor Caraballo informed the residents that due to COVID-19, the seating within the Chambers was limited, but there were procedures in place to ensure all residents would receive an opportunity to have their comments heard.

Planner Daniel Robinson stated that On January 7, 2022, additional information and revisions were provided by the applicant that reflected the removal of all language pertaining to the "T" sign and the "Community" sign, and that the project would still include the proposed digital kiosks, building facade signage, and monument signs. He also stated that the applicant did hold a public meeting on the subject, and the kiosks would be put away from the streets and conservation areas.

Steve Garrett, Lucido & Associates, confirmed that the "T" Sign would be removed from the project and that there would be another community meeting. Vice Mayor Caraballo stated that typically public comment was not heard on first readings, but inquired as to if anyone from the public would like to speak on this item, to which resident Zan Witte spoke and requested a copy that reflected that the sign would be removed.

Vice Mayor Caraballo opened the Public Hearing. (Clerk's Note: A PowerPoint presentation was shown at this time.) Planner Bethany Grubbs gave a presentation on the item and stated that a Special Exception use was being requested for the addition of beer and wine consumption and discussed the evaluation of SEU criteria. Applicant

Cristian Rodriguez informed Council that pursuant to the Planning & Zoning Board's concerns, he had recently applied for a food license.

There being no further discussion, Councilwoman Morgan moved to approve Resolution 22-R01. Councilman Bonna seconded the motion, which passed by roll call vote with Councilwoman Morgan, Councilman Bonna, and Vice Mayor Caraballo in favor and Councilman Pickett opposed.

Planner Holly Price gave a presentation on the item and stated that the Special Exception Use was being requested for the addition of a drive through to the new Subway restaurant. She discussed the Traffic Impact statement and the evaluation of the SEU criteria. Dennis Murphy of Culpepper & Terpening informed the Board that he was available if the Board had any questions.

There being no discussion, Councilwoman Morgan moved to approve Resolution 22-R02. Councilman Pickett seconded the motion, which passed unanimously by roll call vote.

Councilwoman Morgan disclosed that she had ex parte communications with the representative and the applicant. (Clerk's Note: A PowerPoint presentation was shown at this time.) Planner

Daniel Robinson gave a presentation on the item and stated that the Special Exception Use was being requested for repair and maintenance of vehicles, and discussed the traffic impact statement. Vice Mayor Caraballo asked if the Ordinance change in regard to repair and maintenance of vehicles carried with the property, to which Mr. Robinson replied that the Special Exception Use would carry. Vice Mayor Caraballo asked if any type of repair or maintenance could go into that building if the Oil Change didn't work out, to which Mr. Robinson replied that they could as long as it started within a year of the approval as the Special Exception use expired by that time. Attorney Stokes stated that as long as it stayed within that use, it would transfer to the new owner, and Mr. Robinson added that if that use did end and another use went in, the Special Exception use would expire in 6 months due to not being utilized.

(Clerk's Note: A PowerPoint presentation was shown at this time.) Attorney Rob Schwerer of Hayskar, Walker, Schwerer, Dundas & McCain presented the item to the Board and stated that he did not believe that it would be possible for another repair/mechanical company to come in, and that there was a deed restriction in place. He also stated that no one from the public nor Boards had objected to this project and that they met and exceeded all traffic criteria. Attorney Schwerer then presented the conceptual site plan to the Board.

Vice Mayor Caraballo stated that her fear was that they could not guarantee that it could not be utilized for another use, to which Attorney Schwerer responded to her concerns. Vice Mayor Caraballo asked if Attorney Schwerer's statement that another repair shop could not use the facility without a site plan revision was accurate, to which Planner Robinson replied that it was use to use. Vice Mayor Caraballo asked if they could utilize it to fit their fit business, to which Planner Robinson responded in the affirmative.

Jake Seton, C and C Properties, informed the Board that they had a lease with Take5 and the location was geared toward oil changes. Braulio Grajales, Highpoint Engineering, informed the Board of the height of the wall between the facility and the residential neighborhood, and that the property would have a double dumpster solid waste enclosure.

There being no further discussion, Councilman Pickett moved to approve Resolution 22-R03. Councilwoman Morgan seconded the

motion, which passed by roll call vote with Councilwoman Morgan, Councilman Pickett, and Councilman Bonna in favor and Vice Mayor Caraballo opposed.

City Manager Blackburn stated that a memorandum was provided and that the Federal Court approved the City's purchase of the 20 acres for the City Center. He added that they had settlement agreements with all taxing authorities. Vice Mayor Caraballo asked how the City was doing in regard to COVID-19, to which City Manager Blackburn replied that in the last 10 days, the City had 54 cases within their organization, with 75 being monitored. He added that they were providing vaccines for the community with all vaccines available, and they would provide testing information on the City's website.
