ADDENDUM TO AMENDED AGREEMENT FOR ANIMAL SHELTER, BOARD AND CARE

This document serves as an Addendum to the Amended Agreement for Animal Shelter and Care (the "Agreement") between THE CITY OF PORT ST. LUCIE ("City), and the HUMANE SOCIETY OF ST. LUCIE COUNTY, INC. ("Humane Society") (collectively "parties").

WITNESSETH

WHEREAS, on January 21, 2020, the parties entered into an Agreement for Animal Shelter and Care: and

WHEREAS, on January 21, 2020, the parties entered into a Mortgage recorded in Official Records Book 4377, Page 961, St. Lucie County Public Records; and

WHEREAS, the Agreement is in effect through the current term; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

- 1. The term "Loan" as used in the Agreement shall signify the Mortgage entered into by the parties as recorded in Official Records Book 4377, Page 961, St. Lucie County Public Records.
- 2. The term "Operating Assistance" as used in the Agreement shall represent any monies furnished by the City, to the Humane Society, pursuant to Article C. of the Agreement.
- 3. Article C. of the Agreement titled "Payment" shall be amended to reflect an increase to one million, one hundred thousand U.S. dollars (\$1,100,000.00) for the shelter, board and care of animals delivered by the Port St. Lucie Police Department Animal Control Division.
- 4. This Addendum shall be effective as of the date it is fully executed.
- 5. Except as expressly modified by this Addendum, the Agreement shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Addendum and the Agreement, collectively, are the complete agreement of the parties and supersede any prior agreements, addendums or representations, whether oral or written, with respect thereto.
