Dear Mayor Oravec, Vice Mayor Martin, and Council Members:

I'm writing on behalf of the American Society for the Prevention of Cruelty to Animals (ASPCA) and our supporters in Port St. Lucie. In November, the ASPCA wrote to express our concerns about the City's draft proposal to restrict the retail sale of dogs and cats, particularly the problematic loophole that undermines the intended protections. As we noted in that letter, we share Council's concern that the

retail sale of dogs and cats presents risks to both animals and consumers. Unfortunately, the amended proposal before Council on January 11 (First Reading Agenda Item 10.a Ordinance 20-17) would continue to allow pet stores to sell puppies and kittens obtained from certain sources – and thus the proposal maintains the problematic loophole in the law that we have already seen exploited in other jurisdictions.

The amendments made to the language that attempt to exclude animals obtained from breeders will not close the problematic loophole in the ordinance. Allowing pet stores to sell adoptable animals for profit opens the door for industry exploitation. Time and time again, pet store owners have circumvented similar sourcing restrictions by passing cruelly bred animals off as rescued or abandoned. We urge the Council to reject the current proposed language that conflates adoption and retail sales and will be extremely difficult to enforce. Instead, the City should adopt an amendment to clearly and simply prohibit all retail sales of dogs and cats:

ASPCA Proposed Amendment

Ordinance 20-71. Delete Sec. 92.20 (a)-(d) and insert the following:

(a) A pet store shall not sell or offer for sale a dog or cat.

Under this amended proposal, stores can continue to partner with shelters and rescues to provide space in their stores to display adoptable animals, and ownership of the adoption animal remains with the partnering non-profit or governmental organization. This is the model that many retail pet stores currently employ to great success and is the only model the ASPCA supports. It is the most effective way to prevent puppy mill cruelty and safeguard public health and consumers. Absent this language, the ASPCA must oppose this version of the proposed ordinance. We hope you will make the needed amendments to ensure that the City of Port St. Lucie will enact a sound law that effectively addresses the puppy mill problem.
