Thank you very much for taking the time to review this Sole Source justification letter.
Our agency appreciates the efforts of everyone involved who make our city run smooth every day.

Our agency has been directed to evaluate and purchase an armored rescue vehicle which would meet the needs of the City of PSL for the purpose of protecting citizens and police officers during critical incidents and rescue operations. As it should be, an "Armored Vehicle" is not a piece of equipment that can be purchase off a car lot or through the standard procurement procedures. Each armored vehicle is individually built for the needs of the purchaser.
