NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. **SCOPE OF SERVICES**

The Life Scan Wellness program is an integrated medical approach to City Employees exams that combines an annual physical with lifesaving, early detection testing for major diseases such as heart diseases, stroke, cancer, diabetes, and aneurysms before they reach a catastrophic level. It provides each Employee with a thorough assessment of health as well as recommendations for achieving and maintaining long-term wellbeing and managing risks.

2. **CONTRACT RENEWAL:** The parties hereby agree that the contract will be renewed for a 12-month period term as follows:

Beginning Date of Renewal Term: August 27, 2022

End Date of Renewal Term: August 26, 2023

The parties agree the contract will expire at midnight on the date defined as the "End Date of Amendment #1 Term" unless the parties agree to extend the contract for an additional period of time.

3. **SUCCESSORS AND ASSIGNS.** This Amendment shall be binding upon and inure to the benefit of the successors and permitted assigns of the parties hereto.

4. **ENTIRE AGREEMENT.** Except as expressly modified by this Amendment, the contract shall be and remain in full force and effect in accordance with its terms and shall constitute the legal, valid, binding and enforceable obligations to the parties. This Amendment and the contract (including any written amendments thereto), collectively, are the complete agreement of the parties and supersede any prior agreements or representations, whether oral or written, with respect thereto.
