Contract Title: Aquatic Vegetation Control, Add 5 lakes at East Lake Village

Contractor's Name: Aquatic Vegetation control, Inc.

Contract period: 1/01/2007 – 11/1/2010 with two 3 years renewals left on contract

The following modifications to the Terms and Conditions contained in Contract # 20040116 between Aquatic Vegetation Control, Inc., and the City of Port St. Lucie are hereby incorporated and made a part of that Contract.

1. Scope of work is to furnish all materials, herbicides, equipment, and labor as per Schedule 1-3 of Appendix A of contract #20040116. This additional project will include a one-time event initial treatment followed by monthly maintenance for the five (5) lakes in East Lake Village and Hillmoor Lake.

The five lakes have littoral zones. Hillmoor Lake with a perimeter of about 12,000 linear feet has a littoral zone above water of about 10 feet wide. The other four lakes have a combined littoral zone of 12,000 linear feet.

Aquatic Vegetation Control, Inc. will remove all the undesirable weeds that are common in the lakes. The weedy grasses include torpedo grass, crab grass and others. The broad-leaf weeds include hairy indigo, creeping beggar-weed and others.

The initial treatment will not include all the detail work that is needed in the following months. However, the littoral zones will be into a maintenance configuration within 90 calendar days from the initial treatment.

The treatments will include a pre-emergent herbicide to inhibit the growth of unwanted seedlings. The Hydrilla in Hillmoor Lake will also be removed. Aquatic Vegetation Control, Inc., ensures that the most effective, proper and efficient herbicides will be used in both the start-up phase and the monthly maintenance.

The maintenance of these lakes will be monthly and will be supervised by Elroy Timmer who is experienced in littoral zone maintenance.

2. All other terms and conditions of the original contract and/or Addenda apply.
3. Compensation is as follows.

**Initial event** One time initial event: Five thousand Dollars \$5,000.00

**Monthly Maintenance** Two thousand two hundred eighty dollars \$2,280.00
