**AGREEMENT FOR TERMINATION  
OF DEDICATION AND EASEMENT  
ON PLAT**

This Agreement for Termination of Dedication and Easement on Plat (this "Agreement") is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 2025, by and between the CITY OF PORT ST. LUCIE, FLORIDA, a Florida municipal corporation (the "City"), and RIVERLAND COMMUNITY ASSOCIATION, INC., a Florida not for profit corporation (the "Association").

WITNESSETH

WHEREAS, the following plats were recorded against certain real property now owned by the Association located and situate in St. Lucie County, Florida: (i) RIVERLAND PARCEL A – PLAT EIGHT, as recorded in Plat Book 80, at Page 10, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 100; (ii) RIVERLAND PARCEL A – PLAT FOURTEEN, as recorded in Plat Book 87, at Page 33, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 100; (iii) RIVERLAND PARCEL A - PLAT FIFTEEN, as recorded in Plat Book 89, at Page 14; (iv) RIVERLAND PARCEL C – PLAT THREE, as recorded in Plat Book 86, at Page 1, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 107; (v) RIVERLAND PARCEL C – PLAT FIVE, as recorded in Plat Book 86, at Page 33, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 107; (vi) RIVERLAND PARCEL C – PLAT SIX, as recorded in Plat Book 87, at Page 1, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 107; (vii) RIVERLAND PARCEL C – PLAT SEVEN, as recorded in Plat Book 87, at Page 23, as affected by the certain Agreement for Amendment of Dedication on Plat recorded in Official Records Book 4478, at Page 107; and (viii) RIVERLAND PARCEL C – PLAT NINE, as recorded in Plat Book 89, at Page 27; all of the public records of St. Lucie County, Florida (each a "Plat" and collectively, the "Plats"); and

WHEREAS, the Plats were approved for recording on behalf of the City by its City Council; and

WHEREAS, each of the Plats contain on its face a dedication (the, "MME Dedication") of a multi-modal easement (M.M.E.) in favor of the Association (the "Multi-Modal Easement") and the location of such Multi-Modal Easement is depicted on each of the Plats; and

WHEREAS, the MME Dedication grants certain use and maintenance rights within the Multi-Modal Easement in favor of the City and the public; and

WHEREAS, the Association has or will be granting to and in favor of the City a multi-modal easement to replace the Multi-Modal Easement dedicated and established on the Plats and, therefore, the

City and the Association have determined that the MME Dedication and Multi-Modal Easement on each of the Plats is no longer needed and desire to delete the MME Dedication and terminate the Multi-Modal Easement on each of the Plats, as further set forth in this Agreement.

NOW, THEREFORE, in consideration of the mutual terms, conditions and promises hereinafter set forth, the City and the Association agree as follows:

1. The above recitals and representations are true and correct and are made a part of this Agreement by reference.

2. The MME Dedication on each Plat is hereby deleted and the Multi-Modal Easement on each Plat is hereby terminated and of no further force or effect and each are hereby released, relinquished, surrendered, terminated and extinguished of record.

3. This Agreement shall be recorded in the Public Records of St. Lucie County, Florida, by the Association and at the Association's expense. This Agreement, including the benefits and obligations contained herein, shall run with the land and be binding on and inure to the benefit of Association and its grantees, successors, heirs, and assigns holding title to, or otherwise having an ownership interest in, all or a portion of the Plats.

4. Any controversies or legal issues arising out of this Agreement and any action involving the enforcement or interpretation of any rights hereunder shall be submitted to the jurisdiction of the State Courts of the Nineteenth Judicial Circuit, in and for St. Lucie County, Florida, the venue situs, and shall be governed by the laws of the state of Florida.

5. All other notations or dedications on the Plats not amended by this Agreement shall remain in full force and effect.

6. No modification, amendment, or alteration in the terms or conditions contained herein shall be effective unless contained in a written document prepared with the same or similar formality as this Agreement and executed by the City and the Association.
