Comments:	<p>In 2023/2024 the solid waste assessment was \$432.67 and only provided trash and recycling pickup to once a week. Bulk pickup was once a month.</p> <p>For that same year, Unincorporated Palm Beach County residents paid \$461 and received trash pickup twice a week and bulk/recycling weekly. The Village of Wellington residents paid \$478 for the same pickup schedule as Palm Beach County residents. Even our neighbors in Jensen Beach have this same schedule and only paid \$421.65.</p> <p>I am opposed to the price increase. It's clear to myself and other residents that we already overpaid for this waste collection contract, which offers less pickup days than those of other nearby municipalities. Not only should we not approve this</p>



assessment since we overpaid to begin with, we should take this as an opportunity to reconsider our contract and go with a service that offers similar collection frequency and prices as the other municipalities.

Comments: I received the notice of hearing for the assessed increase for solid waste hearing. While I cannot attend the public hearing I wanted to make sure I communicated my opposition to this increase. I also wanted to note that as a working and contributing member of our community, public hearings scheduled at 1:00pm on a weekday are something that many affected city residents including myself will never be able to attend. I recommend we amend the times of public hearings so that city residents can actually attend them. I am also curious how many residents under 60 years old are in attendance at these hearings, considering the times?

I vehemently oppose any increase to our solid waste payment. We all know the problems we have faced in Port Saint Lucie with solid waste over the last 4 years. Our current

program is subpar at best and costing more for us than our previous program.

A one day a week pick up has drastically reduced the cleanliness of our city streets. The cans are often overfilled and spilling out only to be left not picked up by the company due to their very strict rules for pick up. While I would like to say that this is a resident problem and needs to be fixed by residents following the rules for pick up, we all know that it will not improve. The city has done a great job communicating the rules for pick up and yet we lack compliance which will always be an issue.

Our current solid waste company does not have men on the ground to rectify these issues of spilled garbage and overflowed trash coming from the cans being dumped, and therefore leave the mess to the neighborhood. We are also struggling with the smell of rotting trash and maggots on cans left at the roadside. Again a citizen issue, but as we have previously discussed you can't even beg for compliance on an issue of residents cleaning cans and double bagging trash to remedy this issue.

Next, I would like to address the bulk garbage once per month schedule. Many households still put out bulk garbage all month long because they don't know the pick up schedule or because they have no where to store bulk garbage for weeks at a time on their property. Across the city bulk garbage sits at the road not picked up and not cited by code compliance. For all of these reasons I do not feel we should be increasing our payment to solid waste. We should be seeking a better pick up schedule, where trash is not left in cans due to rules, where garbage is picked up more frequently for the cleanliness of our city, and where bulk garbage doesn't line our city streets every day of the year as decoration, or maybe rather as a sad reminder of the subpar solid waste service we are all paying for.





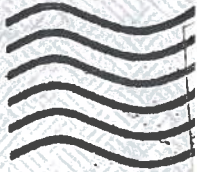
