WHEREAS, the development of the Property shall include artwork ("Artwork") pursuant to Chapter 162, Art in Public Places, in accordance to the city of Port St. Lucie ("City") Code of Ordinances; and

WHEREAS, The City requires this Agreement.

NOW, THEREFORE, in consideration of the covenants set forth herein and other valuable consideration, the receipt of which is hereby acknowledged, CBI agrees as follows:

- 1. **Recitals**. The recitals stated herein are true and correct and incorporated herein.
- 2. Artwork, Restrictive Covenant Running with the Land. The Artwork which is the subject of this Agreement is as depicted on Exhibit "B" and located as shown on Exhibit "C". CBI establishes, declares and prescribes that the Property shall be owned, held, transferred and conveyed subject to this restrictive covenant which shall apply to and be a covenant running with the Property. CBI, its successors and assigns, as owner of the Property or any part thereof, including any mortgagee and any purchaser at a judicial sale hereby covenants and agrees to comply with and be bound by the restrictive covenant in Paragraph 3 below.
- 3. Maintenance of Artwork. The owner of the Property shall be responsible for maintenance of the Artwork in good condition at all times, as determined by the City of Port St. Lucie. The owner of the Property shall be responsible for ensuring that the public's view of the Artwork is maintained and that no vegetation or additional construction obstructs the public's view. Maintenance includes any associated landscaping or related improvements. Retention and maintenance of the Artwork on the Property shall at all times be in compliance with Chapter 162, Art in Public Places, of the City of Port St. Lucie Code of Ordinances.

- 4. **Enforcement**. This restrictive covenant shall be enforceable by legal and equitable means by CBI, its successors and/or assigns, and by the City of Port St. Lucie, Florida.
- 5. <u>Modification and Amendment</u>. This restrictive covenant may only be amended or released by a written instrument executed by CBI and the City of Port St. Lucie, Florida and recorded in the Public Records of St. Lucie County, Florida.


