## 1. Meeting Called to Order

A Regular Meeting of the CITY COUNCIL of the City of Port St. Lucie was called to order by Mayor Martin on July 22, 2024, at 6:01 p.m., at Port St. Lucie City Hall, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida.

3. Invocation & Pledge of Allegiance

Mayor Martin led the assembly in the Pledge of Allegiance.

4. Proclamations and Special Presentations

There was nothing to be heard under this item.

## 5. Public to be Heard

Resident Tracy Kitzler presented a petition for opposition of the changes to the land use for Morningside Blvd. (Clerk's Note: A petition was presented to the Council as an exhibit.)

Resident Kelly Lee spoke in opposition to the proposed PUD change at

Sandpiper and discussed the two file IDs for this project. She stated that they were willing to work with the developer, but he was not making himself available.

Resident John Keck spoke on homeowners being cited for the amount of political signs on their property, but not candidates.

Vice Mayor Caraballo asked for clarification on the two file IDs for Sandpiper, to which Planning & Zoning Director Mary Savage-Dunham stated that P24-033 was the Comprehensive Plan Amendment (Land Use change) and P24-070 was the PUD Amendment and noted that there was still an insufficient application for the PUD so they were waiting to obtain the traffic study. Vice Mayor Caraballo requested for staff to send a courtesy email to the applicant to hold meetings with the residents, and she discussed the political signage regulations, noting that the regulations were for all signs and not just political. Councilman Pickett added that it had to do with total square footage, not just the number of signs.

There being no discussion, Vice Mayor Caraballo moved to approve the Agenda with item 8.a being tabled. Councilman Pickett seconded the motion, which passed unanimously by voice vote.

Resident Cathy Powers spoke in opposition of the location of the TIM Center (Tradition shuttle service) and expressed concern for parking for

the additional buildings and utilizing the Southern Grove DRI for Tradition area plans.

(Clerk's Note: A PowerPoint presentation was shown at this time.) Steve Garrett, Lucido & Associates, presented to the Council on the existing conditions and proposed business for the new site, as well as the addition of new parking spaces.

Councilwoman Morgan requested an update for TIM (Tradition shuttle service) and inquired as to when the delineators could be removed, to which Mr. Garrett replied that the delineators had created a significant reduction in traffic incidents, and Mayor Martin noted that they often get broken and needed better maintenance, and also that it would be nice to make them look more aesthetically pleasing. Eric Sexauer, Tradition Community Development District, discussed the plans for TIM and stated that they were waiting for NHTSA (National Highway Traffic Safety Administration) approval which will take TIM out of the round-about, and that they were in the process of completing the trail in Western Grove which would make TIM move out of the roadway and onto the trail. He also noted that the CDD Engineer already placed an order for replacement delineators. Mr. Sexauer noted that TIM does not operate inside of communities, and he discussed the various shuttle stops. Vice Mayor Caraballo expressed concern for parking for large events.

There being no discussion, Vice Mayor Caraballo moved to approve item 7.d. Councilwoman Morgan seconded the motion, which passed unanimously by voice vote.
