For the valuation of the Subject Property we have concentrated properties with similar current Highest and Best Uses as the Subject Property. We analyzed the Subject Property base on the sales comparison approach as this is the most recognized unit of comparison in this market. All of the comparables were considered with regard to property rights appraised, time or market conditions, location, size, access, site quality, and zoning. The three comparable sales indicated a non adjusted range from \$180,000 to \$265,000 and an adjusted range of \$191,000 to \$198,750. 




