

**CITY OF PORT ST. LUCIE
SITE PLAN REVIEW COMMITTEE MEETING MINUTES
April 23, 2025**

1. CALL TO ORDER

A Regular and Virtual Meeting of the SITE PLAN REVIEW COMMITTEE of the City of Port St. Lucie was called to order by Chair Cox on April 23, 2025, at 1:30 p.m. at Port St. Lucie City Hall, Building B, Training Room, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida and via Zoom.

3. APPROVAL OF MINUTES – February 12 & March 26, 2025

There being no corrections, the minutes were approved.

4. ADDITIONS AND/OR DELETIONS

Ivan Betancourt, Planner I, added Construction Plans to P25-061. Francis Foreman, Planner III, amended P07-002-A4 as it was a Major, not Minor Site Plan. Dan Robinson, Planner III, added P24-223, Central Park Commercial Preliminary & Final Plat to the agenda.

Mr. Glover **moved** to approve the amended agenda. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

6. REVIEW OF DEVELOPMENT PROJECTS

P24-222 Southern Grove, Tradition Nature Trail, Resubmittal Minor Site Plan, Construction Plans

Scott Wolff, Lucido & Associates, represented the Applicant.

Bridget Kean, Planning & Zoning Deputy Director, voiced that she had landscaping concerns. She advised the Committee that staff was recommending approval with the following conditions, all documents and agreements required for the construction of the nature trail, as determined by the City, on City, or CDD or other property must be finalized and a timeline for the submittal of

required easements and any additional agreements must be established before the issuance of the first PW permit. All final easements, including but not limited to permanent easements providing public access to the trail, and other agreements required by the City to facilitate the nature trail's operation and maintenance must be finalized and approved by the City prior to the trail being open to the public.

Mr. Glover **moved** to approve P24-222, Southern Grove, Tradition Nature Trail, Resubmittal Minor Site Plan, Construction Plans with the stated condition and all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

P25-058 Southern Grove, St. Matilda Off-Site Lake Clearing Plan, Construction Plans

Jayson Harrison, Hayley Ward, represented the Applicant.

Mr. Glover **moved** to approve P25-061, Tradition 4, Brynlie Amenity Center Minor Site Plan, Landscape Plan, with all comments being addressed. Ms. Zsoka **seconded** the motion, which **passed unanimously** by voice vote.

P24-223 Central Park Commercial Preliminary & Final Plat
