PCS INCLUDES FO Cable **Relocation and/or Removal** scope of work only when specified by plans notes or special provisions and specifically quoted with a unit price in PCS proposal.

PCS EXCLUDES tracer wire and/or locate wire from scope of work included in PCS proposal.

PCS EXCLUDES any/all conduit, pull/splice box, FO tubular delineator removal, relocation or installation which may be required by project specifications or plan notes. All modifications needed to conduits, pull boxes, markers or other infrastructure shall be performed by others.

- **General - Fiber Optic Locator Per Day Pay Item 633-6**

PCS INCLUDES price to provide a Fiber Optic Locator on a PER CONTRACT DAY basis as provided in proposal.

Pay Item 633-6 will include a PCS Trained fiber optic cable locator with tools onsite when locates are called 48 hours in advance to Sunshine One Call and PCS direct. The client shall provide PCS 48 hours of notice to schedule locator services.

PCS will perform the FO locates, but additional measures may need to be taken by the Client where congestion does not allow for above ground locate methods to accurately identify subsurface fiber optic cables.

Emergency Locates are defined as locates with less than 48 hours' notice. PCS will make a good faith effort to provide emergency locates when PCS has an available locator. Emergency locates will be invoiced at 1.5 times the quoted daily rate.
