A RESOLUTION OF THE CITY OF PORT ST. LUCIE, FLORIDA AUTHORIZING THE SETTLEMENT OF LITIGATION; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

**WHEREAS,** in August of 2023 Moxie Pest Control Florida, LLC ("Plaintiff") filed a complaint against the City of Port St. Lucie, Florida ("City") in the U.S. District Court for the Southern District of Florida alleging, *inter alia*, that aspects of Chapter 112 of the City's Code of Ordinances covering door-to-door solicitation is unconstitutional; and

**WHEREAS**, the above-referenced dispute is styled *Moxie Pest Control Florida*, *LLC v*. *City of Port St. Lucie*, *Florida*, Case No. 23-14250-Civ-DMM; and

**WHEREAS,** Plaintiff seeks remedies including statutory attorneys' fees, temporary and permanent injunctive relief, and declaratory relief; and

WHEREAS, court-mandated settlement conferences were held on December 12 and 20 of 2023 where the Federal Magistrate Judge assigned to the matter served as mediator during those conferences; and

WHEREAS, following the discussions held at those settlement conferences, the Federal Magistrate, as mediator proposed a settlement to fully and finally resolve the dispute between the parties, which Plaintiff has accepted; and

WHEREAS, Plaintiff has agreed to withdraw all pending claims with prejudice upon the following terms: (1) the City amends Chapter 112 of the Code of Ordinances to prohibit door-to-door solicitation after 8 p.m.; (2) Plaintiff agrees to the retention of the fingerprinting requirement in Chapter 112 of the Code of Ordinances; (3) the City agrees to not enforce private restrictions set forth by homeowner associations on door-to-door solicitation; and (4) both parties agree to pay their own fees and costs; and

WHEREAS, this Resolution authorizes the settlement of the dispute in accordance with the above-referenced terms and conditions; and

**WHEREAS**, the City Council finds that the settlement of this dispute serves a valid public purpose.

## NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PORT ST. LUCIE, FLORIDA:

<u>Section 1.</u> <u>Ratification of Recitals.</u> The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

<u>Section 2.</u> <u>Conflict.</u> If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 3</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.
