

**AMENDMENT NUMBER ONETO
AGREEMENT DATED AUGUST 12, 2020
BETWEEN CITY OF ORLANDO AND
BRENNTAG MID-SOUTH, INC.**

THIS AMENDMENT TO AGREEMENT is made and entered into this ____ day of _____, 2022, by and between the City of Orlando, a municipal corporation organized and existing under the laws of the State of Florida, hereinafter referred to as the "City" and "BRENNTAG MID-SOUTH, INC.", hereinafter referred to as the "Contractor".

WHEREAS, the City and the Contractor entered into an Agreement ("the Agreement") under the date of August 12 2020, whereby the latter would perform certain services with respect to the liquid gas services and

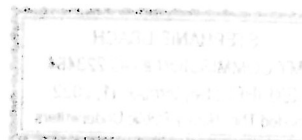
WHEREAS, the City and the Contractor desire to amend the compensation of services of said Agreement to increase the price of services.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

I. Compensation Provisions

The Compensation provisions of the Agreement are hereby amended to increase cost of products due to rapid increasing cost of Chlorine and as set forth in Exhibit "A" attached hereto and incorporated herein by reference. The pricing set forth will be \$1,385.00/ton for a six (6) month period. The Procurement and Contracts Division shall be notified of any reductions in pricing as it would supersede most recent approved price increase in the best interest of the City. The Procurement and Contracts Division will review the information at the six (6) month period to determine if it is in the best interest of the City to adjust the pricing on the products, in conjunction with the Contractor's effective date of price increase.

In all other respects, and except as specifically modified and amended herein and in the Agreement dated August 12, 2020, shall continue in full force and effect as written and the parties hereto agree to be bound thereby.

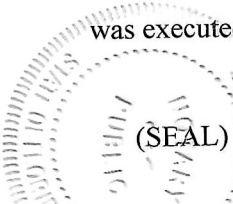
