A RESOLUTION APPROVING THE FINAL PLAT WITH CONSTRUCTION PLANS FOR TELARO AT SOUTHERN GROVE WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF MATTAMY PALM BEACH, LLC (P21-013); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

<u>Section 3</u>. That the Mayor and City Clerk of the City of Port St. Lucie, Florida, are hereby authorized to countersign the said plat so it may be properly recorded in the public records of St. Lucie County, Florida.

<u>Section 5</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable.
