A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO AND EXECUTE A SUPPLEMENTAL AGREEMENT TO THE LOCAL AGENCY PROGRAM AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, WHICH PROVIDES COMPLETE FUNDING FOR THE INSTALLATION OF ADAPTIVE TRAFFIC SIGNAL SYSTEM EQUIPMENT AT SIX (6) INTERSECTION ALONG SW GATLIN BOULEVARD FROM SW VILLAGE PARKWAY TO SW SAVONA BOULEVARD; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

WHEREAS, by Resolution 22-R93, the City of Port St. Lucie (the "City") entered into a Local Agency Program Agreement (the "LAP Agreement") with the Florida Department of Transportation (the "FDOT"), which provided \$600,000.00 of federal funding assistance for the installation of adaptive traffic signal control system equipment at six (6) intersections along SW Gatlin Boulevard from SW Village Parkway to SW Savona Boulevard (the "Project"); and

WHEREAS, prior to competitive solicitation for construction of the Project, the total construction cost of the Project was estimated at \$712,567.00; and

WHEREAS, following competitive solicitation and award for construction of the Project on March 13, 2023, the total construction cost is now estimated at \$477,254.00; and

WHEREAS, the City has now been issued a Supplemental Agreement to the LAP Agreement with the FDOT that proposes to reduce the amount of federal funding assistance for the Project to \$477,254.00, which equals the total construction cost estimate and shall cover same via a cost reimbursement approach; and

WHEREAS, the FDOT has allocated funds represented in the LAP Agreement; and WHEREAS, the FDOT has requested that the City adopt a resolution expressing support of the Supplemental Agreement; and

WHEREAS, the FDOT has requested that the City adopt a resolution expressing support of the Project and authorizing the City Manager to enter into and execute the Supplemental Agreement; and

WHEREAS, as expressed in Resolution 22-R93, the City supports the Project and desires to continue to pursue the Project in partnership with the FDOT.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PORT ST. LUCIE, FLORIDA, THAT:

<u>Section 1.</u> <u>Ratification of Recitals</u>. The foregoing recitals are hereby ratified and confirmed as true and correct and are hereby made a part of this Resolution.

Section 2. Authorization. The City Manager, or his designee, is hereby authorized to enter into, execute and deliver to FDOT the Supplemental Agreement to the LAP Agreement, and such other documents as are necessary to implement the terms of the Supplemental Agreement and LAP Agreement. Moreover, the City Manager and City Engineer, and/or their designees, are hereby authorized to take all actions necessary to work with the FDOT to accomplish the purposes set forth in the Supplemental Agreement and LAP Agreement.

<u>Section 3.</u> <u>Conflict.</u> If any resolutions, or parts of resolutions, are in conflict herewith, this Resolution shall control to the extent of the conflicting provision(s).

<u>Section 4.</u> <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
