

P24-124 City of Port St. Lucie Large Scale Text Amendment Infrastructure Element

> Adoption Hearing City Council Meeting December 9, 2024

Request Summary

- This is the adoption hearing for a city initiated large scale comprehensive plan text amendment (CPA) to amend Policy 4.D.2.1.1 of the Infrastructure Element to adopt the 2022 update to the City's Water Supply Facilities Work Plan.
- The City Council transmittal hearing was on September 23, 2024.
- The Florida Department of Commerce issued their comment letter on October 25, 2024.
- There were no objections to the proposed amendment from the Florida Department of Commerce or the reviewing agencies.
- The South Florida Water Management District did offer some technical guidance and the plan has been updated to address their comments.

Project Background

- The City is located within the SFWMD Upper East Coast Water Supply Planning Area which encompasses Martin and St. Lucie counties as well as the northeastern portion of Okeechobee County.
- State law requires the City to adopt a 10-year water supply facility work plan to be adopted into the comprehensive plan.
- The Work Plan projects water demands for at least a 10-year period to demonstrate that the current and planned water supply facilities and source(s) of water meet the projected demands.
- The City's 10-Year Water Supply Facility Work Plan was adopted in December 2008 and updated in 2013 and 2018 following the updates to the Upper East Coast Water Supply Plan.



Project Background

- The water supply plan has to be updated every 5 years following an update to the regional water supply plan.
- The Upper East Coast Water Supply Plan was last updated in November 2021.
- The Utility Systems Department update to the City of Port St. Lucie Water Supply Facility Work Plan 2022 was approved by the SFWMD in July 2024.
- The 2022 Update will serve as the City's Five (5) Year update to its 10 Year Water Supply Facilities Work.



Proposed Amendment

- The City's water supply facilities work plan is adopted by reference per Policy 4.D.2.1.1 of the Infrastructure Element.
- The amendment to Policy 4.D.2.1.1 is attached as Exhibit "A" of the staff report.
- The update to the Water Supply Facilities Work Plan is attached as Exhibit "B" of the staff report.



Staff Recommendation

- The Planning and Zoning Board recommended approval at the September 5, 2024, Planning and Zoning Board meeting.
- The City Council held a transmittal hearing on September 23, 2024.
- No objections from state or reviewing agencies
- The Planning & Zoning (P&Z) Department staff finds the petition to be consistent with the intent and direction of the City's Comprehensive Plan and recommends approval.
