

AN "INGRESS AND EGRESS EASEMENT AND AN "ACCESS EASEMENT", AS SHOWN HEREON, ARE DEDICATED FOR THE BENEFIT OF THE OWNERS OF LOTS 1 AND 4, SYMPATICO PLAZA AS RECORDED IN PLAT BOOK 73, PAGE 3 OF THE PUBLIC RECORDS OF ST. LUCIE COUNTY, FLORIDA, THEIR SUCCESSORS AND ASSIGNS, , SYMPATICO PLAZA 1, AS RECORDED IN PLAT BOOK 73, PAGE 21 OF SAID PUBLIC RECORDS, FOR UN-RESTRICTED INGRESS AND EGRESS ACROSS SAID EASEMENTS. AN EASEMENT OVER AND UNDER SAID "INGRESS AND EGRESS EASEMENT" AND SAID "ACCESS EASEMENT", AS SHOWN HEREON, IS ALSO RESERVED IN FAVOR OF THE CITY OF PORT ST. LUCIE, ITS SUCCESSORS AND ASSIGNS, FOR THE CITY OF PORT ST. LUCIE SERVICE AND EMERGENCY VEHICLES. THE CITY OF PORT ST. LUCIE SHALL NOT BE RESPONSIBLE FOR ANY MAINTENANCE OBLIGATIONS FOR SAID EASEMENT EXCEPT AS SHALL RELATE TO THE SERVICING OF SUCH PUBLIC UTILITIES BY THE CITY OF PORT ST. LUCIE.
- 2. UTILITY EASEMENTS NO. 1 AND NO. 2 AS SHOWN HEREON ARE RESERVED IN FAVOR OF THE CITY OF PORT ST. LUCIE, ITS SUCCESSORS AND ASSIGNS FOR ACCESS TO, AND INSTALLATION AND MAINTENANCE, OF PUBLIC FACILITIES, INCLUDED BUT NOT LIMITED TO, WATER AND WASTEWATER LINES AND APPURTENANT FACILITIES. THERE SHALL BE NO IMPROVEMENTS OF ANY KIND (INCLUDING, BUT NOT LIMITED TO, LANDSCAPING) CONSTRUCTED WITHIN THE BOUNDARIES OF THE UTILITY EASEMENTS, EXCEPT PAVING FOR DRIVEWAYS AND/OR PARKING AREAS. PORT SAINT LUCIE PROPERTIES, LLC, ITS SUCCESSORS OR ASSIGNS, SHALL OWN, MAINTAIN, REPAIR AND REPLACE ANY PERMITTED IMPROVEMENTS (AS SET FORTH IN THE SENTENCE IMMEDIATELY PRECEDING) OVER THE UTILITY EASEMENT, WHICH MAY BE DAMAGED OR DESTROYED BY THE CITY OF PORT ST. LUCIE, ITS SUCCESSORS OR ASSIGNS, DESIGNEES OR CONTRACTORS IN THE OPERATION, MAINTENANCE, OR ACCESS TO, THE PUBLIC UTILITIES FACILITIES. THE CITY OF PORT ST. LUCIE, ITS SUCCESSORS OR ASSIGNS, SHALL HAVE THE RIGHT TO REQUIRE THE REMOVAL OF ANY IMPROVEMENTS WHICH ARE CONSTRUCTED IN VIOLATION OF THE CONDITIONS SET FORTH ABOVE. IN THE EVENT SUCH VIOLATING IMPROVEMENTS ARE NOT REMOVED UPON REQUEST, THEY SHALL BE SUBJECT TO REMOVAL BY THE CITY OF PORT ST. LUCIE, ITS SUCCESSORS OR ASSIGNS, DESIGNEES OR CONTRACTORS WITHOUT LIABILITY OR RESPONSIBILITY THEREFOR.
- 3. A PERPETUAL, NON-EXCLUSIVE EASEMENT AND RIGHT-OF-WAY AS SHOWN HEREON IS RESERVED IN FAVOR OF FLORIDA CITY GAS, A PUBLIC UTILITY NEW JERSEY CORPORATION, ITS SUCCESSORS AND ASIGNS FOR THE PURPOSES OF LAYING, CONSTRUCTING, MAINTAINING, OPERATING, REPAIRING, ALTERING, IMPROVING, INSPECTING, REPLACING OR REMOVING FROM TIME TO TIME PIPELINES WITH VALVES, SERVICES AND ALL OTHER APPURTENANT FACILITIES, FOR THE TRANSPORTATION OF GAS, OR ANY LIQUIDS, GASES, SUBSTANCES OR OTHER MATERIALS THAT CAN BE TRANSPORTED BY OR CONDUCTED THROUGH PIPELINES, AS RECORDED IN OFFICIAL RECORDS BOOK 3879, PAGE 2588, OF THE PUBLIC RECORDS OF ST.
