This amendment to the current contract would include monthly rodent monitoring at the above location, adding a total of 5 stations for \$9.00 each for initial one-time set-up cost and \$45.00 per monthly service per each station for the Community Center location only.
 - B) Final cost of Amendment #2 would be \$2,745.00 with \$2,700.00 Annual cost after initial set up.
