SUBJECT: 2021 Legislative Session –Week 2 Summary (March 8-12)

The second week of the 2021 Legislative Session provided a few hints on the state of the state budget.

Notably, Senate President Wilton Simpson delivered some good news for lawmakers and lobbyists with appropriation requests in the hopper — the Trilby Republican wants to use money heading to Florida through the recently passed federal stimulus package to fund one-time projects rather than use it to fill budget gaps in recurring programs.

Florida is expected to receive about \$8 billion from the plan.

Meanwhile, Gov. Ron DeSantis suggested using some of the funding to pay for a proposed bonding program, Resilient Florida, which would provide grants to local governments to help them complete projects that address sea-level rise or nuisance flooding.

This week also brought progress on COVID-19 liability protections, which the Senate is merging into one bill after previously splitting health care and business shields into separate bills. "It's easier to defend one fortress than to guard two. I think it's important that we have both the business community and the health care community rowing with us together in the same ship," said Sen. Jeff Brandes, who is carrying the liability bills in the upper chamber.

Gov. DeSantis also announced this week that Adrian Lukis would take over as Chief of Staff, replacing Shane Strum, who announced last month that he would leave the position to take a job as CEO of Broward Health. Lukis, previously one of Strum's top deputies, starts Monday.

On the COVID-19 front, the vaccine rollout continued outpacing the virus' spread, and the total number of Floridians who are fully inoculated has now eclipsed the number who have been diagnosed with COVID-19. At the end of the week, Florida had recorded just under 2 million

cases over the past year, while more than 2.1 million received either both doses of a two-dose vaccine or the single-dose Johnson & Johnson vaccine.

Important to municipalities and counties, the legislation would provide an appeal mechanism for citizens to challenge a decrease in funding to the police department, as well waive sovereign immunity for municipalities that inhibit a local law enforcement's ability to protect citizens during a riot.

Summary of Session Week 2 (March 8-12)

Tallahassee Week in Review

In case you missed it, here is an update on last week's legislation to watch:

Revamped Clemency Rules — Gov. DeSantis and the Florida Cabinet adopted an "automatic process" to speed up the restoration of rights for felons who have completed all terms of their sentence, including paying fines and fees. The process also eliminates the five-year waiting period before felons can apply for restoration.

State Preemption of Seaport Regulations Legislation (HB 267 by Rep. Roach/SB 426 by Sen. Boyd) — The bills would preempt local government ordinances that "restrict or regulate commerce" at Florida seaports, including restrictions on the size or type of ships that can dock at port. The provision targets a Key West ordinance aimed at keeping cruise ships away from the island. The House version cleared its first committee earlier this month. The Senate version was approved by the Senate Transportation Committee last week with a 6-2 vote.

Construction Defects Legislation (HB 21 by Rep. Andrade/SB 270 by Sen. Perry) The bills would change the procedure for property owners taking action against contractors for construction defects. It would require the owner to first seek a claim under warranty and notify the contractor of the alleged defect. The House version passed the House Regulatory Reform Subcommittee this week on a party-line vote.

Resilient Florida Legislation (HB 7019 by Rep. Busatta Cabrera) — The House Environment, Agriculture and Flooding Subcommittee voted unanimously to introduce proposed committee bills that would create the Resilient Florida Grant Program to help local governments address the impact of sea-level rise and nuisance flooding. The first bill (previously PCB EAF 21-01) creates the program. A second bill (HB 7021, previously PCB EAF 21-02) creates the Resilient Florida Trust Fund within the Department of Environmental Protection.

Grandparent Tuition Waiver Legislation (<u>HB 1273 by Rep. Maney/SB 1728 by Sen. Baxley</u>) — The bills allow students from out of state to pay in-state college tuition rates if their grandparents are Florida residents. The student must also score in the 89th percentile or higher on the ACT or SAT. The House bill cleared its second of three committees last week.

Civic Education Curriculum Legislation (<u>HB 5 by Rep. Zika/SB 1450 by Sen. Rodriguez</u>) — The bills would require high school government classes to include a comparative discussion of political ideologies, including communism. The Department of Education would also create a media library "including first-person accounts of victims of other nations' governing philosophies." Last week, the House version passed its second committee, and the Senate version passed its first.

Beverage Law Legislation (SB 148 by Sen. Bradley) — The bill would allow restaurants to continue selling alcoholic beverages to-go after the pandemic ends, as long as they are purchased alongside food. The bill is headed to its final committee stop after clearing the Senate Commerce and Tourism Committee with a unanimous vote.

Online Sales Tax Legislation (HB 15 by Rep. Clemons/SB 50 by Sen. Gruters) — The bills would harness the 2017 U.S. Supreme Court decision in *South Dakota* v. *Wayfair* to require most out-of-state retailers to collect and remit sales tax. The legislation is expected to boost sales tax revenues by more than \$1 billion a year. The House version passed its first committee this week, while the Senate bill is now ready for a floor vote. Also this week, House Speaker Sprowls and Senate President Simpson announced plans to use the additional revenues to refill the state's unemployment trust fund.

Election Administration Legislation (SB 90 by Sen. Baxley) — The bill would change several election laws, including shortening the length of time a vote-by-mail ballot request is valid from two election cycles to one. The bill cleared the Senate Governmental Oversight and Accountability Committee over protest from Democratic lawmakers and public speakers, including former Sen. Alan Hays, who called the legislation a "travesty."

Senate Transportation Package (SB 1126 by Sen. Harrell/SB 1500 by Sen. Harrell) — The Senate began work on this years' transportation package. The bills are packed with changes to state transportation laws, including provisions to raise the bonding cap for right-of-way acquisition

and provide the Florida Department of Highway Safety and Motor Vehicles subpoena powers in odometer fraud, title fraud, or driver's license fraud investigations.

Preview of Week 3 (March 15-19)

Agency Presentations — The Senate Select Committee on Pandemic Preparedness will hear presentations from the Central Florida Behavioral Health Network, Department of Veterans Affairs, and the Department of Children and Families when it meets at 1 p.m. on Monday.

Member Projects — The House Higher Education Appropriations Subcommittee will consider two-dozen appropriations projects bills when it meets on Monday at 3 p.m. A full listing is available on the committee meeting notice.

Une mployment System Legislation (<u>HB 1463 by Rep. LaMarca/SB 1948 by Sen. Bean</u>) — The legislation would make numerous changes intended to improve Florida's unemployment benefits system, including implementing a disaster preparedness plan and "continuous modernization initiatives." The legislation comes after an inspector general investigation revealed the system, which crashed at the start of the pandemic, underwent little stress testing before it was rolled out to the public. The Senate Commerce and Tourism Committee will hear SB 1948 when it meets on Monday at 3:30 p.m.

Technology Transparency Legislation (HB 7013 by Rep. Ingoglia) — The House Appropriations Committee will take up Gov. DeSantis' priority legislation to penalize social media companies for "deplatforming" users or changing terms of service without advance notice. The House Commerce Committee introduced the bill, formerly PCB COM 21-01, last week. It goes before the House Appropriations Committee at 3:45 p.m. on Monday.

Vaccine Fraud Prevention Legislation (HB 9 by Rep. Zika/SB 1608 by Sen. Bean) — The legislation would increase penalties for vaccine-related schemes, such as fraudulently advertising access to COVID-19 vaccines in exchange for money. Last week, HB 9 became the first measure to pass the House this session. The Senate companion will go before the Senate Criminal Justice Committee, its first stop, at 12:30 p.m. on Tuesday.

Home Book Delivery for Elementary Students (HB 3 by Rep. Trabulsy/SB 1372 by Sen. Burgess) — The legislation would create the "New Worlds Reading Initiative," which would provide free books to elementary school students who are reading below grade level. It is a priority of House Speaker Chris Sprowls. The House version has cleared two committees. The Senate version will go before the Senate Education Committee at 12:30 p.m. on Tuesday.

Appointments Considered — The Senate Ethics and Elections Committee will decide whether to advance a dozen gubernatorial appointees to state boards when it meets on Tuesday at 3 p.m.

Federal Spotlight

American Rescue Plan Signed into Law

On Wednesday, the U.S. House of Representatives approved <u>HR 1319</u>, the American Rescue Plan Act, by a vote of 220-211. U.S. Rep. Jared Golden (D-ME) was the only Democrat to vote against it; no Republicans voted for it. President Joe Biden signed the bill yesterday, saying the law was "about rebuilding the backbone of this country and giving people in this nation — working people and middle-class folks, the people who built the country — a fighting chance." Direct payments to eligible households will start going out before the end of the month.
