A RESOLUTION APPROVING AND ACCEPTING THE PRELIMINARY PLAT WITH CONSTRUCTION PLANS FOR MARSHALL PARKWAY AT SOUTHERN GROVE, WITHIN THE CITY OF PORT ST. LUCIE, FLORIDA ON THE REQUEST OF CULPEPPER AND TERPENING (P23-048); PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

Mattamy Palm Beach, LLC, or it's successors, shall provide corner clips for the road right-of-way at the NE and SE corners of Marshall Pkwy and Community Blvd prior to Final Plat approval. The City will not entertain any request to accept the roadway for ownership and maintenance until this is accomplished.

<u>Section 3</u>. <u>Conflicts.</u> If any Resolution, or parts of any Resolution, are in conflict herewith, this Resolution shall control to the extent of the conflicting provisions.

<u>Section 4</u>. <u>Severability</u>. The provisions of this Resolution are intended to be severable. If any part of this Resolution is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Resolution shall remain in full force and effect.

<u>Section 5.</u> <u>Effective Date</u>. This Resolution shall become effective immediately upon adoption.
