A Regular Meeting of the CITY COUNCIL of the City of Port St. Lucie was called to order by Mayor Martin on April 28, 2025, at 6:01 p.m., at Port St. Lucie City Hall, 121 SW Port St. Lucie Boulevard, Port St. Lucie, Florida.

Mayor Martin led the assembly in the Pledge of Allegiance.

4. Proclamations and Special Presentations

5. Public to be Heard

Resident Gregory Pressley II spoke on the Milner Dr sidewalks, stating that it has unnecessary restrictions, but not all areas have them, and that his area has the most space, but they're unable to use it and the police have been called on him for using the space. Mayor Martin inquired if there was any ex-parte communication, to which the Council responded in the negative. (Clerk's Note: Mayor Martin later disclosed that she did have discussions with the applicant on this parcel.)

(Clerk's Note: A PowerPoint presentation was shown at this time.) Bridget Kean, Planner, stated that she was sworn in and that the file was submitted to the City Clerk's Office 5 days prior to the meeting and requested that it be entered into the record. She presented to the Council and stated that the request was for a major amendment to the America Walks-Becker Road MPUD regulation book and concept plan. She discussed the project background, the proposed project, and land use consistency.

Steve Garrett, Lucido & Associates, represented the applicant. Vice Mayor Caraballo inquired about the intent of the parcel once it changed to industrial, to which Mr. Garrett replied that the residential component of the MPUD had already been fulfilled with America Walks project, and they had active applications with the City right now for commercial opportunities. Councilwoman Morgan inquired about the distance from signal to signal because it seemed too close, to which Clyde Cuffy, Public Works, replied that the intersection was always meant to have a signal. Councilwoman Morgan then inquired about a road connection with Martin County, to which Ms. Kean replied that she could not speak on discussions between the applicant and Martin County, but the road in the middle did not have access to go further south.

Mayor Martin opened the Public Hearing. There being no public to be heard, she closed the Public Hearing. There being no further discussion, Vice Mayor Caraballo moved to approve Ordinance 25-22. Councilman Bonna seconded the motion, which passed unanimously by voice vote.

(Clerk's Note: A PowerPoint presentation was shown at this time.) Bethany Grubbs, Planner, stated that she was sworn in and that the file was submitted to the City Clerk's Office 5 days prior to the meeting and requested that it be entered into the record. She presented to the Council and stated that the request was a City-initiated Zoning Code Amendment to define 'virtual auto sales dealers' and to establish regulations, revise rear setbacks in select districts, and correct a PUD conceptual plan submittal text error. She discussed the proposed amendments and definitions for 'virtual auto sales' in Section 153.01, the Industrial Zoning District for Section 158.110, Neighborhood Convenience Commercial for Section 158.120, Warehouse Industrial Zoning District for Section 158.135, Section 158.177 Changes in Conceptual Plans, and a new section for Virtual Auto Sales which was Section 158.212.

Councilwoman Morgan inquired as to where the staging would happen, to which Ms. Savage-Dunham clarified that this would be more of a specialty, and that people would not walk around to browse, and trucks would not unload. Vice Mayor Caraballo expressed that she was in favor.

Mayor Martin opened the Public Hearing. There being no public to be heard, she closed the Public Hearing. There being no discussion, Vice Mayor Caraballo moved to approve Ordinance 25-24. Councilwoman Morgan seconded the motion, which passed unanimously by voice vote.

Mayor Martin opened the Public Hearing. There being no public to be heard, she closed the Public Hearing. There being no discussion, Vice Mayor Caraballo moved to approve Ordinance 25-25. Councilman Bonna seconded the motion, which passed unanimously by voice vote.

Mayor Martin inquired if there was any ex-parte communication, to which the Council responded in the affirmative.

(Clerk's Note: A PowerPoint presentation was shown at this time.) Bridget Kean, Planner, stated that she was sworn in and that the file was submitted to the City Clerk's Office 5 days prior to the meeting and requested that it be entered into the record. She presented to the Council and stated that the request was for a 7th amendment to the Tradition DRI Development Order to amend the development entitlements, amend certain conditions of approval, revise the conversion matrix, and update the project phasing, buildout, and expiration dates per statutory extensions. She discussed the background of the project, future land use, existing location, the proposed amendment, proposed changes to entitlements and p.m. peak hour trips, and additional changes and revisions.

Mayor Martin inquired about what was different since it was currently two lanes and asked if they were planning to remove the delineators, to which Clyde Cuffy, Public Works, replied that the developer was going to do a study to determine any updates and/or if the delineators needed to be removed, and also that there would be bilinear reports done to determine if a traffic signal would be required in the future. Mayor Martin requested that the roundabouts be maintained properly through Mattamy or the

Community Development District (CDD), and that the safety aspect of the delineators should remain while studies were being conducted. Mr. Cuffy stated that the delineators were always meant to be temporary and agreed that they were not being maintained properly, to which Mayor Martin stated that maybe they shouldn't be talking about keeping this 2-lane roundabout.

Vice Mayor Caraballo stated that she did not recall a discussion with Mattamy to increase the number of units or some of these changes being part of the discussion, and she inquired as to why they did not receive a one-on-one meeting. Ms. Kean stated that they had sent out a memo and would be happy to conduct one-on-one meetings. Vice Mayor Caraballo suggested that they table this item and requested a meeting with the applicant as well. Councilman Bonna expressed agreement with Vice Mayor Caraballo's statements and stated that he was not prepared to support this item tonight, so he recommended tabling the item.

Ms. Kean continued the presentation with discussion on the analysis, combined development totals for Tradition and Western Grove DRIs, and traffic studies. (Clerk's Note: She advised that the traffic consultant was present via Zoom.) City Attorney Berrios then clarified the process for the public hearing. Councilwoman Morgan and Ms. Kean discussed the total units allowed per policy.

Steve Garrett, Lucido & Associates, represented the applicant and elaborated on the discussion for the number of units, and he stated that they provided a response to resident Cathy Powers per her public comments prior to the meeting. He stated that for the conditions they suggested for the commitments to be date certain, and he clarified that they were not proposing any additional units anywhere that Council or staff hadn't seen before on other applications. Mayor Martin inquired if the additional units were going to be put where Slopeside was going to be, to which Mr. Garrett replied that this was just correcting the overall needs of the DRI and not a specific parcel, and that Slopeside was now called Lotus and had an active application with the City. Vice Mayor Caraballo stated that she wants to meet with staff to better understand the requests and impacts to the City, and Councilman Bonna and Councilman Pickett expressed agreement. Councilman Pickett also expressed frustration with the timing of receiving the memo and the position that they were being put in. Mayor Martin agreed with having the date certain added, but she had concerns about the roundabout.

Mayor Martin opened the Public Hearing. Resident Cathy Powers stated that there needed to be a finer look at Tradition because it was not viable, and that they needed to look at the intersection of Crosstown Pkwy and

Village Pkwy and include looking at the seconds/minutes of the traffic signals. She also suggested doing a speed analysis and reducing the speed to 35mph between Westcliff and Crosstown since there were 2 different speeds. Ms. Powers also expressed concerns about there not being any guard rails for safety. There being no further public to be heard, Mayor Martin closed the Public Hearing.

There being no further discussion, Councilman Bonna moved to table Resolution 25-R12 to the May 27, 2025, City Council meeting. Vice Mayor Caraballo seconded the motion, which passed unanimously by voice vote.

There being no discussion, Vice Mayor Caraballo moved to approve Resolution 25-R24. Councilwoman Morgan seconded the motion, which passed unanimously by voice vote.

The City Clerk read Resolution 25-R25 aloud by title only.

Resident Cathy Powers inquired as to how often DOGE would be reporting to the public and who the experts of the investigations/examinations would be.

Councilman Bonna stated that this was different than what he had proposed and what other cities had implemented, and he discussed the goals of this Resolution. He stated that Section 3 – 'Commitment to a Good Faith Partnership' was removed and he would like it added back into the Resolution. Vice Mayor Caraballo discussed local government transparency, and that Port St. Lucie does well with transparency to the residents, and Councilman Pickett stated that they had been doing it all along, but he would be in support of this Resolution if it gives more comfort. Mayor Martin stated that she was fine with the current draft. Councilwoman Morgan stated that she was fine with readding Section 3 and inquired as to why it was removed, to which City Attorney Berrios replied that the Whereas Clause had captured the commitment therein the Resolution, but he could amend this upon discretion of the Council. Councilman Bonna stated that it wouldn't hurt to add it, and if it wasn't added there could be a lot of negative implications in the media.

There being no further discussion, Councilman Bonna moved to approve Resolution 25-R25 with the addition of the language, "Whereas the State of Florida has set the example of operating efficiently for the sake of being good stewards of the taxpayer dollars." Councilwoman Morgan seconded the motion, which passed unanimously by voice vote.

12. Unfinished Business

Councilman Bonna addressed the memorandum from City Attorney Berrios, and

City Attorney Berrios explained this and stated that the conclusion was that there was no legally binding agreement declaring the city of Port St. Lucie as a sister city.

13. New Business

There was nothing to be heard under this item.

14. City Manager's Report

There was nothing heard under this item.

15. Councilmembers Report on Committee Assignments

Councilwoman Morgan – She attended the Transportation Planning Organization, Breakfast with a Lifesaver event, Amazon warehouse tour, Fire Board meeting, and the Tourist Development Council. She discussed the Ordinance that stated, “North of Midway”, and informed that it was passed unanimously to remove that vocabulary. She also mentioned that Port St. Lucie just turned 64 years old, and informed of the NW Bayshore Blvd corridor public meeting.

Councilman Pickett – He attended the Transportation Planning Organization, the Fifth Third Bank ribbon cutting, and Port St. Lucie’s birthday celebration. He also informed of the Tree Giveaway.
