

**ORDINANCE 23-**

**AN ORDINANCE OF THE CITY OF PORT ST. LUCIE, FLORIDA, REZONING A 0.23-ACRE PROPERTY, LOCATED EAST OF SW SOUTH MACEDO BOULEVARD AND NORTH OF CROSSTOWN PARKWAY, FROM SINGLE-FAMILY RESIDENTIAL (RS-2) ZONING DISTRICT TO SERVICE COMMERCIAL (CS) FOR PROPERTY LEGALLY DESCRIBED AS PORT ST. LUCIE SECTION 28, BLOCK 240, LOT 3 (P23-126); PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Imperium Construction Co., LLC., seeks to rezone a 0.23-acre property located at 1429 SW South Macedo Boulevard, north of Crosstown Parkway, and within the City of Port St. Lucie, from Single-Family Residential (RS-2) Zoning District to Service Commercial (CS) Zoning District; and

**WHEREAS**, the proposed zoning is consistent with all applicable elements of the City's adopted Comprehensive Plan and complies with the City's Code of Ordinances; and

**WHEREAS**, the City of Port St. Lucie Planning and Zoning Board held a public hearing on September 5, 2023 to consider the rezoning application (P23-126), notice of said hearing to adjoining property owners for a radius of seven hundred and fifty (750) feet having been given and advertising of public hearing having been made; and

**WHEREAS**, the City Council held a public hearing on October 9, 2023, to consider the rezoning application (P23-126), advertising of the public hearing having been made; and

**WHEREAS**, the City Council has considered the rezoning application (P23-126) based on substantial and competent evidence and the City Council has determined to rezone the property legally described as Port St. Lucie Section 28, Block 240, Lot 3, as provided herein.

**ORDINANCE 23-**

**NOW, THEREFORE, THE CITY OF PORT ST. LUCIE HEREBY ORDAINS:**

**Section 1. Ratification of Recitals.** The City Council of the City of Port St. Lucie, Florida, hereby adopts and ratifies those matters as set forth in the foregoing recitals.

**Section 2.** That the property located at 1429 SW South Macedo Boulevard, north of Crosstown Parkway, and legally described as Port St. Lucie Section 28, Block 240, Lot 3, be rezoned from Single-Family Residential (RS-2) Zoning District to Service Commercial (CS) Zoning District; and

**Section 3. Conflict.** If any ordinance, or parts of ordinances, or if any sections, or parts of sections, of the ordinances of the City of Port St. Lucie, Florida, are in conflict herewith, this Ordinance shall control to the extent of the conflicting provisions.

**Section 4. Severability.** The provisions of this Ordinance are intended to be severable. If any provision of this Ordinance is determined to be void or is declared illegal, invalid, or unconstitutional by a Court of competent jurisdiction, the remainder of this Ordinance shall remain in full force and effect.

**Section 5. Effective Date.** That this Ordinance shall become effective ten (10) days after its final adoption.
