Good Morning Councilman Pickett,

My husband, Dave and I have resided in TownPark since 2008. In addition to serving on my community committees and Boards, I served as a Tradition CDD #6 Supervisor (2010-2018). The purpose of this communication is to draw your attention to an aspect of the Tradition Trail, which I find extremely troublesome and causes me great concern.

After being approved and a part of the City's Comp Plan for years, the Nature Trail in Tradition is under attack. The continuous trail has been promised to the residents of Tradition for years. The builder of the Del Webb community was well aware of the Trail and provided easements for it. The ADA striping and gates where it will cross Gingerline Drive are already in place.

The builder's maps of Del Webb, on their own website, clearly show the passage of the trail. There is no reason for the residents of Del Webb to say they were unaware of the Trail. Below is a screenshot of the map from their own website! The white path through the greenspace is Tradition Trail. It is clearly marked and clearly shows the trail crossing Gingerline Drive.



The trail approval and easement predate the first home sold in Del Webb by over 10 years. It is crazy to let the voice of a couple hundred un-informed residents outweigh the desires of the thousands of other Tradition residents who have been promised this Trail for over 15 years. Easements for this Trail, in existence since 2006, run through this preserve land which is owned by the local CDD. Open prairies, restored wetlands, and one of the only remaining oak hammocks in the Southern Grove region, allow for a trip through nature that is seldom found in suburbia.

The preserve land is vital to supporting the recently restored wetlands, native plants and animals in the area. This trail will give the residents of Tradition and Port Saint Lucie as a whole, a “real Florida” experience, showing us what the area was like prior to development, all while providing a home for our native plants and animals.

In response to a recent article “Move that Trail”, in my opinion, the Trail must remain in its’ original planned location within this urban greenway. Among its’ offerings will be wetlands for a nature park with educational opportunities, natural areas for viewing wildlife and photography, hiking and biking. To relocate any portion of the continuous Trail, running it parallel and alongside an existing paved roadway, in my opinion, defeats the purposeful use of this urban greenway.

My ask of you: Respect the Plan.... 2006; Keep the Location; Complete the Trail.... NOW
