 - B. Aerex will supply field technicians to remove and transfer membrane elements to an empty train, install new pressure vessels followed by re-installation of membrane elements from the next train in the sequence. Related material to be supplied by owner. **Preice (per skid) \$37,850.00 for a total of \$189,250.00**
 - C. Forklift Variable Reach 7000# 38-44' Rental. Price (per day) for a total of \$8,296.00
