Re: Plans to rezone the property located at the corner of
Westmorland and Morning Side.
As many of you know this is a second attempt to try and rezone
this area.
The previous attempt to rezone this area for an Assisted Living
area – drug Rehab center or other unknown multi housing
facility failed

First, I must say that the timing of your notification has been
very unprofessional. There has been no formal notice to the
residents of the area
I am unaware of any area residents that have received a formal
notice of meeting – nor do we see any signage at the area
I would also state that there is a formal process for notification

of zone changes and public input -but it appears as if our elected city officials have neglected to provide this information to their citizens that they are supposed to represent.

2.) It is the feeling of our household at 2777 SE Bluem Way, Port Saint Lucie, Florida 34952 that the use of the property in question for an assisted living facility is a deterrent to the neighborhood

3.) The Addition of a multi-unit facility Will increase an already overcrowded roadway, as well as decrease the safety of the many individuals who walk and bike along these roads

4.) As you should know, assisted living facilities are very prone to the need for Emergency Services, often several times a day. The frequent EMS calls for service present quite a challenge, to traffic as well as noise.

This area is also home to several Protected species of animals, that would be put in harm's way due to the increase in traffic, the increased noise, and the destruction of the natural habitat.

5.) We are both Nurses at our address and you have not addressed the concerns over the biological hazards that would be produced from the facility.

There will be frequent blood draws resulting in dirty needles and blood-soaked gauze that will need to be disposed of properly.

The elder population is also subject to frequent open wounds that are breeding grounds for MRSA, Vancomycin Resistant Bacteria, Tissue Sloughing, and viral shedding.

These patients will require surgical equipment as well as a detailed plan of the disposal of surgical implements and wound care dressings used in their care.

6.) The area surrounding this property is used by visitors from all over the United States. It is an area that is also subject to frequent downpours of rain. As I do work in Health Care I do know that, No matter how good a sales person says a protective container is, Water will penetrate the container and Will leak out onto the surrounding area.

This has a high potential for exposing the citizens in this neighborhood to Viral Illness, Bacterial infections, used sharps and needle sticks and now multiple strains of communicable diseases that are as of yet to be discovered

The area is home to Raccoon's, Rabbits, Rats, and other varmints. It would only take the contamination of one Varmint, to create a vector which could spread multiple diseases to the local wild life as well as community. This will endanger the citizens of the area

Also, serious contamination of the nearby waterways due to biologic and Viral Runoff is a high probability. We have low water level sources to the homes in the area and multiple homes that remain on septic. Imagine if a homes septic tank became infected with a pathogen of serious consequences

7.) Linen and the removal is of another concern. As you may not know, linen is not handled as biological waste. Open containers are held outside of the facilities for night pick up by various companies. These linens are often urine stool and blood soaked,

These Linen containers are are not locked. They have an open area that allows for anyone – child animal or demented patient to reach into and remove the linens to be moved to anywhere The linen bags are not impermeable to water as this is not a requirement, Therefore, again, this will allow for the fluids to spill upon the area.

Also the nightly pickup of these linens are generally around 1am to 3am, with large truck using back up sirens as a precaution. This noise is certainly not needed in this area of residential

housing.

8.) I also do not believe that proper permits are in place to allow for the storage and removal of biological hazard waste in this area and I have not seen an environmental impact study on the complete effects of allowing a facility as such to be constructed in this area

9.) As an ALF this facility would also run the risk of the occasional "wandering" patient.

Directly behind the proposed site is a smaller pond that often is frequented by alligators. Some more than 6 foot in length. Further, less than a half block away is an unfenced lake that is not only very deep, but also contains many alligators. Having worked in health care for over 25 years, I can say that no door alarm is perfect, and at some time, a resident will decide to wander.

If a patient happens to wander from the facility and drown, attacked by an alligator or hit by an automobile, The City WILL be partly responsible for allowing this facility to be built without proper safeguards

10.) Regarding a 2-story structure, We find this to be totally unacceptable, as well as structurally unsound. The property is bordered by several open areas, during a severe Hurricane wind can react over and above 130 to 150 mph. The underlying ground is not strong enough to support the added weight, and allow for the Dade County restrictions – Also we have not seen a construction plan that incorporates Dade County Wind and Storm Protections – if they do exist at all

Regarding improper wind mitigation, the lack of puts the lives of any residents in jeopardy.

11.) Also the disposal of everyday trash has not been considered. These containers do not require locks, and as we all

know are frequented by multiple animals looking for waste foods. This also presents a problem as the smell of decaying foods cannot be contained.

We would also be subject to the smell of heating Urine Blood and Stool in the bins that are stored outside

12.) Also you have also not advised what age group this facility is going to serve. Too frequently this area requests to open a "so called" Assisted Living Facility, when in turn the plan is to open housing for drug rehabilitation of addicted individuals.

As such the wording of this document needs to address the true nature of this facility, and the population it will serve. You also need to disclose the intended owner and operator of the facility as I and my fiancé work frequently

with the DCF, and have a vast understanding of several individuals who have been and are trying to open this area for their collected gain. Several of these individuals are known to operate in violation of city codes, with an unnamed few who claim to live at the facility, but have domicile in other areas 13.) It is our given opinion that this notification was shadowed from the general public with the intent to bypass the public input, in order to limit the number of individuals that would like to speak at this "meeting"

Ms Mayor and the members of the council, prior to any approval of amendments, I would highly suggest a very detailed study on the impact that a facility like this would have on this area.

I would also recommend the release of the names of the owners and individuals who are going to run this facility, and a complete police background check on the individuals who would be staffing the facility.

We also request a study on the increase in operational costs

due to an increase in garbage pickup, Increased lighting, increasing road maintenance Increased use of Emergency Services, Increased need for police patrol to monitor for missing residents,

Also a detailed study on the amount and type of traffic and its increase due to this structure.

Sandpiper Bay will not stand by and allow for widening of the surrounding roadways to accommodate a facility that was never zoned to be in this residential area

I would suggest that this be done at the cost of the builder, as this is a private organization and it is their responsibility to present honest and fair information to our community, I am sure I speak, not only for myself but for many in this area.

Comments:	<p>The Sandpiper Bay community roads were not developed for the extra traffic that is now daily. The calming sections do not slow traffic. This is supposed to be a residential community not a speedway for cars or have traffic backups.</p> <p>Westmoreland currently has speeding, tailgating, cars passing on the center median and passing in the Westmoreland/SE Pine Valley circle.</p> <p>Westmoreland and SE Morningside has traffic for the current service entrance for the Sandpiper Bay Resort utilized by staff, deliveries, etc.</p> <p>Westmoreland will become more threatening to travel for residents.</p> <p>Sandpiper Bay Community residents have only two (2) crosswalks on Westmoreland for crossing. It is dangerous to cross Westmoreland at any point with cars speeding. The SE</p>

Pine Valley circle does not have sidewalks for residents to cross from either direction within the circle.

The new Port development will add traffic to Westmoreland.
